- 4 (14) TWO PRACTICAL NURSING STUDENTS LICENSED IN THE STATE; 5 AND
- 6 (15) ANY OTHER INDIVIDUAL WITH EXPERTISE OR EXPERIENCE THAT 7 THE SECRETARY DETERMINES IS RELEVANT TO THE COMMITTEE.
- 8 (D) THE SECRETARY SHALL DESIGNATE THE CHAIR OF THE COMMITTEE.
- 9 (E) THE DEPARTMENT SHALL PROVIDE STAFF FOR THE COMMITTEE.
- 10 (F) A MEMBER OF THE COMMITTEE:
- 11 (1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE 12 COMMITTEE; BUT
- 13(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE14STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.
