2 Maryland Health Benefit Exchange and Maryland Department of Health 3 - Health Care and Dental Care Coverage for Undocumented Immigrants -4 Report

FOR the purpose of requiring the Maryland Health Benefit Exchange and the Maryland Department of Health to develop a report comparing options for offering affordable health care <u>and dental care</u> coverage to State residents who are ineligible for the Maryland Medical Assistance Program, the Maryland Children's Health Program, or qualified health plans, <u>or stand-alone dental plans</u> due to the individuals' immigration status; and generally relating to a study on providing health care <u>and</u> dental care coverage to undocumented immigrants.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 13 That:

- (a) The Maryland Health Benefit Exchange and the Maryland Department of Health shall develop a report comparing options for offering affordable health care <u>and dental care</u> coverage to State residents who are ineligible for the Maryland Medical Assistance Program, the Maryland Children's Health Program, or qualified health plans <u>or stand-alone dental plans</u> through the Maryland Health Benefit Exchange due to the individuals' immigration status.
- (b) The report required under subsection (a) of this section shall include a comparison of the cost to the State, the impact on the uninsured, potential benefits designs, and implementation considerations for:
