Environmental Health Specialists and On-Site Sewage Disposal Systems Well

and Septic Systems Permitting - Reform Studies

(Environmental Health Systems Support Act of 2023)

FOR the purpose of requiring the Department of the Environment to develop and make available certain standardized permit forms; requiring a local health department to provide a certain applicant with certain information under certain circumstances: requiring the Maryland Department of Health to promote consistent standards and regulations governing environmental health specialists, host certain monthly information meetings, and develop an online tracking system for on-site sewage disposal system permits; requiring the Department of Budget and Management, on or before a certain date, to increase the number of full-time employees in the Department of the Environment by a certain number of permanent, classified positions; establishing the Environmental Health Specialist Student Loan Forgiveness Program; requiring an applicant selected to participate in the Program to sign a contract agreeing to a certain service obligation; authorizing the Office of Student Financial Assistance to make certain annual disbursements directly to a Program participant under certain circumstances: requiring the Department of the Environment and the Maryland Department of Health, in conjunction with the Board of Environmental Health Specialists, to conduct a certain study; requiring the Department of the Environment, to contract in consultation with the Department of Legislative Services and the University of Maryland Agriculture and Food Systems Extension Program, to conduct a certain study; and generally relating to studying environmental health specialists and well and septic systems permitting.
