Real Property – Expedited Wrongful Detainer Proceedings – Property for Sale
 or Lease

- 4 FOR the purpose of requiring certain expedited proceedings in a wrongful detainer action 5 if the property that is the subject of the action is, at the time of the complaint, 6 advertised or listed for sale or lease by the complainant and requiring that notice of 7 a hearing or appeal be served in person or, under certain circumstances, posted 8 conspicuously on the property; requiring the District Court or the circuit court to 9 issue a warrant within a certain number of hours if the court rules in favor of the complainant in an expedited wrongful detainer action; and generally relating to a 10 11 wrongful detainer action for possession of real property.

- 4 (4) Notice of the order for a hearing shall be served on the parties or the 5 parties' counsels not less than 5 days before the hearing.
