in lines 24 and 25, strike "DEPARTMENT OF TRANSPORTATION" and substitute "STATE HIGHWAY ADMINISTRATION, IN CONSULTATION WITH THE DEPARTMENT,"; strike beginning with "UPDATE" in line 25 down through "STANDARDS" in line 28 and substitute "DEVELOP DESIGN GUIDELINES FOR BRIDGES, CULVERTS, AND ROADS THAT WILL IMPROVE PASSAGE FOR SPECIES DESIGNATED UNDER SUBSECTION (B)(2) OF THIS SECTION"; in line 29, strike "THE" and substitute "ON COMPLETION OF THE DESIGN GUIDELINES REQUIRED UNDER SUBSECTION (D) OF THIS SECTION, THE"; in the same line, after "SHALL" insert "CONSIDER THE DESIGN GUIDELINES AND MAY"; and in line 30, strike "OF ALL NEW" and substitute ", REHABILITATION, OR REPLACEMENT OF".

On page 5, strike beginning with "(I)" in line 3 down through "TIMELINE" in line 36 and substitute "NOTHING IN THIS SUBSECTION MAY BE CONSTRUED TO REQUIRE THE STATE HIGHWAY ADMINISTRATION TO INCORPORATE INTO THE DESIGN, REHABILITATION, OR REPLACEMENT OF A BRIDGE, CULVERT, OR STATE HIGHWAY ANY DESIGN ELEMENTS RECOMMENDED IN THE DESIGN GUIDELINES REQUIRED UNDER SUBSECTION (D) OF THIS SECTION THAT:

- (I) SIGNIFICANTLY INCREASE THE PROJECT COST OR TIMELINE; OR
- (II) ARE UNREASONABLE, UNFEASIBLE, OR NOT IN ACCORDANCE WITH RELEVANT SAFETY STANDARDS AND ENGINEERING BEST PRACTICES".

REASONABLE, AND FEASIBLE, AND FOR WHICH STATE MATCHING FUNDS ARE AVAILABLE"; and after line 23, insert:

"(I) THE DEPARTMENT SHALL:

- (1) DEVELOP A WEBSITE TO BE USED FOR ACCEPTING DONATIONS
 TO THE FUND; AND
- (2) IF FEASIBLE, WORK WITH THE MOTOR VEHICLE ADMINISTRATION TO PROVIDE THE OPTION, APPEARING ON THE VEHICLE REGISTRATION PORTAL, TO DONATE TO THE FUND.".

On page 9, strike in their entirety lines 19 through 29, inclusive, and substitute:

"SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or application to any project that has an existing National Environmental Policy Act record of decision and for which the design of the project is more than 30% complete before the effective date of this Act.".
