"SECTION 4. AND BE IT FURTHER ENACTED, That:

- (a) This section applies to an individual who:
 - (1) is employed in a position affected by this Act on July 1, 2024; and
- (2) <u>has no creditable service in the Employees' Pension System before</u> July 1, 2008.
- (b) An individual described in subsection (a) of this section shall have the individual's service credit from the Employees' Pension System transferred and combined with the individual's service in the Correctional Officers' Retirement System.";

and in lines 10 and 19, strike "4." and "5.", respectively, and substitute "5." and "6.", respectively.
