On page 1, after line 17, insert:

- (ii) 1. This subparagraph applies only to a member of the State Police Retirement System.
- 2. If a member of the State Police Retirement System who transferred from another actuarial retirement system in the State retires after less than 3 years of employment as a member of the State Police Retirement System, the earnable compensation as a member in the other system shall be used in the determination of average final compensation.

- (ii) 1. This subparagraph applies only to a member of the State Police Retirement System.

If a member of the State Police Retirement System who transferred from another actuarial retirement system in the State retires after less than 5 years of employment as a member of the State Police Retirement System, the earnable compensation as a member in the other system shall be used in the determination of average final compensation.

 - 1. IS COMPLETED BY THE MEMBER'S EMPLOYER; AND
- 2. <u>CERTIFIES THAT THE MEMBER RECEIVED A</u>
 <u>SALARY INCREASE IN ACCORDANCE WITH PARAGRAPH (2)(II) OF THIS</u>
 SUBSECTION.
