"BY repealing and reenacting, without amendments,

<u>Article - Housing and Community Development</u> <u>Section 1–101(a), (c), and (i)</u> <u>Annotated Code of Maryland</u> (2019 Replacement Volume and 2023 Supplement)".

in lines 19 and 20, strike "COUNTY AND BALTIMORE CITY" and substitute "<u>POLITICAL SUBDIVISION</u>"; and in line 22, strike "COUNTY OR BALTIMORE CITY" and substitute "<u>POLITICAL SUBDIVISION</u>".

On page 2, in line 1, strike "COUNTY OR BALTIMORE CITY" and substitute "<u>POLITICAL SUBDIVISION</u>"; in line 4, after "(2)" insert "<u>EACH POLITICAL</u> <u>SUBDIVISION SHALL DETERMINE A MINIMUM PERIOD OF TIME FOR A VACANT</u> <u>COMMERCIAL BUILDING TO BE ELIGIBLE FOR INCLUSION IN THE INVENTORY</u> <u>REQUIRED UNDER PARAGRAPH (1)(I) OF THIS SUBSECTION.</u>

<u>(3)</u>";

in the same line, strike "COUNTY AND BALTIMORE CITY" and substitute "POLITICAL SUBDIVISION"; in line 15, after "(B)" insert "ON REQUEST BY A POLITICAL SUBDIVISION, THE DEPARTMENT SHALL PROVIDE TECHNICAL ASSISTANCE TO THE POLITICAL SUBDIVISION IN CREATING AND SUBMITTING THE REPORT REQUIRED UNDER THIS SECTION.

and after line 17, insert:

# "(D) THE DEPARTMENT SHALL ADOPT REGULATIONS TO ESTABLISH STANDARDS FOR POLITICAL SUBDIVISIONS TO USE IN DETERMINING WHETHER A
