AMENDMENTS TO HOUSE BILL 149

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**and Kerr**” and substitute “**, Kerr, Pena-Melnyk, Cullison, Alston, Bagnall, Bhandari, Chisholm, Hill, Hutchinson, S. Johnson, Kaiser, Kipke, R. Lewis, Lopez, Martinez, M. Morgan, Reilly, Rosenberg, Szeliga, Taveras, White Holland, and Woods**”; in line 2, strike “**Authorization**” and substitute “**Notice and Retrieval**”; strike beginning with the third “and” in line 4 down through “request” in line 7 and substitute “**; requiring that the notice required to be provided regarding the destruction of medical records be made by e-mail**”; and strike beginning with “, if” in line 8 down through “provided,” in line 9.

AMENDMENT NO. 2

On page 3, in line 10, strike the brackets; strike beginning with “**PROVIDES**” in line 10 down through “**FROM**” in line 12; in line 12, strike “**, THE HEALTH CARE PROVIDER**”; in lines 13 and 17, in each instance, strike “**10**” and substitute “**7**”; in line 19, strike the brackets; strike beginning with “**PROVIDES**” in line 19 down through “**REPORT**” in line 21; in line 23, strike the brackets; strike beginning with “**PROVIDES**” in line 23 down through “**RECORD**” in line 25; in line 26, strike the first set of brackets; in the same line, strike “**A REQUEST MADE**”; in line 28, strike “first-class” and substitute “**:**”

(I) FIRST-CLASS”;

in the same line, after “patient;” insert “**AND**”; after line 28, insert:

“(II) E-MAIL TO THE LAST KNOWN E-MAIL ADDRESS OF:

1. THE PATIENT; OR

2. IF THE PATIENT IS A MINOR AND THE MEDICAL CARE DOCUMENTED IN THE RECORD WAS NOT PROVIDED UNDER § 20–102(C) OR § 20–103(C) OF THIS ARTICLE, THE PARENT OR GUARDIAN OF THE PATIENT;

in line 29, strike the brackets; in lines 29 and 30, strike “IS PROPOSED TO”; and in line 30, strike the brackets.

On page 4, strike beginning with “IF” in line 3 down through “RECORD” in line 5; strike beginning with “IF” in line 6 down through “THE” in line 7 and substitute “THE”; in line 10, strike “PROPOSED”; strike beginning with “REQUEST” in line 11 down through “DESTROY” in line 12 and substitute “NOTICE OF DESTRUCTION OF”; strike beginning with the colon in line 18 down through “Forward” in line 19 and substitute “FORWARD”; in line 19, strike the brackets; strike beginning with “DESCRIBED” in line 19 down through “SUBSECTION” in line 20; in lines 22 and 23, strike “(I)” and “(II)”, respectively, and substitute “(1)” and “(2)”, respectively; and strike beginning with “; or” in line 25 down through “wanted” in line 31.
