"SCHOOL STAFF MEMBER" MEANS AN INDIVIDUAL WHO IS 3 EMPLOYED ON A FULL-TIME BASIS AT AN ELEMENTARY OR SECONDARY SCHOOL IN 4 THE STATE AS: 6 (I)A TEACHER; (II)7 AN ADMINISTRATOR; 8 (III) A PARAPROFESSIONAL; 9 (IV) A SCHOOL PSYCHOLOGIST; 10 (V) A SCHOOL SECRETARY; 11 (VI) A GUIDANCE COUNSELOR; OR 12 (VII) ANY OTHER SCHOOL EMPLOYEE. - 13 (E) THE ADMINISTRATION MAY FACILITATE THE MARKETING OF THE 14 PROGRAM WITH PRIVATE EMPLOYERS, COUNTY AND MUNICIPAL GOVERNMENTS,
- 15 AND, WHERE APPROPRIATE, OTHER UNITS OF STATE GOVERNMENT AND NONPROFIT

- 12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- October 1, 2024. It shall remain effective for a period of 3 years and, at the end of September
- 14 30, 2027, this Act, with no further action required by the General Assembly, shall be
- 15 abrogated and of no further force and effect.
