# Baltimore County Board of Education – Nonstudent Member Compensation and Student Member Scholarships – Alterations

FOR the purpose of altering the annual compensation of certain nonstudent members of
the Baltimore County Board of Education; providing that the chair of the county
board is entitled to a certain annual compensation; altering the amount that a
student member of the board is granted for a certain scholarship; and generally
relating to annual compensation and scholarship amounts for members of the
Baltimore County Board of Education.

AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary 14or compensation of the nonstudent members of the Baltimore County Board of Education 1516 or the scholarship amount for the student member of the Baltimore County Board of 17Education while serving in a term of office beginning before the effective date of this Act, 18but the provisions of this Act concerning the salary or compensation of the nonstudent 19 members of the Baltimore County Board of Education and the scholarship amount for the 20student member of the Baltimore County Board of Education shall take effect at the beginning of the next following term of office. This limitation does not apply to an individual 2122appointed or elected after the effective date of this Act to fill out an unexpired term.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 1, 2024.
