- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

Article – Transportation

20 17–104.

(a) The Administration may not issue or transfer the registration of a motor
vehicle unless the owner or prospective owner of the vehicle furnishes evidence satisfactory
to the Administration that the required security is in effect.

1 (b) The owner of a motor vehicle that is required to be registered in this State 2 shall maintain the required security for the vehicle during the registration period.

(c) Each insurer or other provider of required security shall:

4 (1) [Except as provided in item (2) of this subsection, immediately notify 5 the Administration electronically of new motor vehicle insurance policies issued for insured 6 vehicles registered in the State; and] **PARTICIPATE IN THE ADMINISTRATION'S ONLINE** 7 VERIFICATION PROGRAM FOR VEHICLE INSURANCE POLICIES FOR LAW 8 ENFORCEMENT AND ADMINISTRATIVE PURPOSES;

9 (2) For each fleet policy, electronically notify the Administration every 30 10 days of any additions, deletions, or modifications to the fleet policy, including those policy 11 numbers affected; AND

12 (3) ELECTRONICALLY PROVIDE THE ADMINISTRATION WITH ALL 13 ACTIVE INSURANCE POLICIES:

(I) IN A FORMAT REQUIRED BY THE ADMINISTRATION; AND

(II) AT AN INTERVAL DETERMINED BY THE ADMINISTRATION.

16 (d) The Administration, in consultation with the Maryland Insurance 17 Administration and representatives of the automobile insurance industry, shall adopt 18 regulations that establish procedures to be used by an insurer to provide timely notification 19 to an insured of the penalties that may be imposed in accordance with § 17–106 of this 20 subtitle if the insured fails to renew or replace a policy of motor vehicle liability insurance 21 without surrendering the evidences of registration.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 23 October 1, 2024.
