- 11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.

- 15 (a) The dispute settlement mechanism provided by this section applies to any
- 16 complaint or demand formally arising on or after [January 1, 2015] OCTOBER 1, 2023,

- 5 [(ii)] (III) At the hearing, the member shall have the right to present 6 evidence and to present and cross—examine witnesses regarding the alleged violation.
- [(iii)] (IV) Prior to imposing any sanction on the member, the governing body shall place in the minutes of the meeting proof of the notice provided to the member under paragraph (3) of this subsection, which shall include:
- 10 A copy of the notice, together with a statement of the date and manner of [the delivery of] **PROVIDING** the notice; or
- 12 2. A statement that the member in fact appeared at the 13 hearing.
- [(iv)] (V) The governing body shall place in the minutes of the meeting the results of the hearing and the sanction, if any, imposed on the member.
- 16 (5) If the member does not request a hearing within the time 17 Frame Specified in the notice given under paragraph (3) of this 18 Subsection, the governing body, at the next meeting, shall deliberate 19 As to whether the violation occurred and decide whether a sanction is 20 Appropriate for the violation.
- 21 (c) A member may appeal a decision of a governing body made in accordance with 22 the dispute settlement procedure described in this section to the courts of Maryland.
- 23 (d) (1) If a member fails to comply with this subtitle, the bylaws of a cooperative housing corporation, or a decision rendered by the governing body in accordance with this section, the governing body or any other member of the cooperative housing corporation may sue the member for any damages caused by the failure or for injunctive relief.
- 28 (2) The prevailing party in a proceeding authorized under this subsection 29 is entitled to an award for reasonable attorney's fees as determined by court.
- 30 (e) The failure of a governing body to enforce a provision of this title, the 31 proprietary lease of a member, or the bylaws of the cooperative housing corporation on any 32 occasion is not a waiver of the right to enforce the provision on any other occasion.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to have any effect on or

- application to any complaint or demand formally arising under the rules of a cooperative housing corporation or the provisions of a member's proprietary lease before the effective date of this Act, unless the bylaws of the cooperative housing corporation or the proprietary lease of the member who is a party to the dispute states otherwise.
- 5 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 6 October 1, 2024.
