# A BILL ENTITLED

# 2 Juvenile Law – Complaints – Forwarding to State's Attorney

- FOR the purpose of repealing an exception to the requirement that a complaint that alleges
  the commission of an act by a child that would be a felony if committed by an adult
  must be forwarded to the State's Attorney under certain circumstances; and

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

16 (c) (4) (i) [1. Except as provided in subsubparagraph 2 of this 17 subparagraph, if] **IF** a complaint is filed that alleges the commission of an act which would 18 be a felony if committed by an adult or alleges a violation of § 4–203 or § 4–204 of the 19 Criminal Law Article, and if the intake officer denies authorization to file a petition or 20 proposes an informal adjustment, the intake officer shall immediately:

[A.] **1.** Forward the complaint to the State's Attorney; and

[B.] 2. Forward a copy of the entire intake case file to the State's Attorney with information as to any and all prior intake involvement with the child.

The need for restitution may be considered as one factor in the public interest. After the preliminary review the State's Attorney shall, within 30 days of the receipt of the complaint by the State's Attorney, unless the court extends the time:
15	1. File a petition or a peace order request or both;
