### 1 AN ACT concerning

# Election Law - Election Disinformation on Large Social Media Platforms and Influence Related to Voting

4 FOR the purpose of requiring each large social media platform to make reasonable efforts  $\mathbf{5}$ to prevent, detect, and remove accounts and posts that communicate election 6 disinformation in the State; requiring a large social media platform to report election 7 disinformation by providing certain information to the State Board of Elections 8 within a certain period of time after the large social media platform becomes aware of an account or a post that communicates election disinformation; requiring the 9 State Board to take certain action as soon as practicable after receiving a report from 1011 a large social media platform concerning an account or a post that communicates 12election disinformation; defining "influence" for purposes of a certain provision of law 13 related to offenses related to voting; and generally relating to election disinformation 14 on large social media platforms.

1 DISINFORMATION, THE LARGE SOCIAL MEDIA PLATFORM SHALL REPORT THE 2 ELECTION DISINFORMATION BY PROVIDING THE FOLLOWING TO THE STATE BOARD, 3 IF KNOWN:

4 (1) THE NAME OF THE ACCOUNT RESPONSIBLE FOR THE 5 COMMUNICATION OR THE POST;

6 (2) THE DATES AND TIMES THAT THE COMMUNICATION WAS FIRST 7 DISSEMINATED AND LAST DISSEMINATED;

8 (3) A DIGITAL COPY OF THE CONTENT OF THE COMMUNICATION;

9 (4) AN APPROXIMATE DESCRIPTION OF THE GEOGRAPHIC LOCATIONS 10 TO WHICH THE COMMUNICATION WAS DISSEMINATED;

11(5) AN APPROXIMATE DESCRIPTION OF THE AUDIENCE THAT12RECEIVED OR WAS TARGETED TO RECEIVE THE COMMUNICATION; AND

13(6) THE TOTAL NUMBER OF IMPRESSIONS GENERATED BY THE14COMMUNICATION.

15 (D) AS SOON AS PRACTICABLE AFTER RECEIVING A REPORT UNDER 16 SUBSECTION (C) OF THIS SECTION, THE STATE BOARD SHALL:

17(1)MAKE THE INFORMATION AVAILABLE ON THE STATE BOARD'S18WEBSITE; AND

19(2) MAKE A REASONABLE ATTEMPT TO CONTACT THE INDIVIDUALS20OR ENTITIES THAT RECEIVED THE COMMUNICATION IN ORDER TO NOTIFY THE21INDIVIDUALS OR ENTITIES OF THE NATURE OF THE COMMUNICATION.

(E) (1) IN ADDITION TO ANY OTHER SANCTION PROVIDED BY LAW, IF A
LARGE SOCIAL MEDIA PLATFORM FAILS TO FILE A REPORT UNDER THIS SECTION,
THE STATE BOARD MAY ASSESS A CIVIL PENALTY AGAINST THE LARGE SOCIAL
MEDIA PLATFORM IN AN AMOUNT NOT EXCEEDING:

- 26 (I) **\$10,000** FOR A FIRST OFFENSE;
- 27 (II) **\$25,000** FOR A SECOND OFFENSE; AND
- 28 (III) \$50,000 FOR A THIRD OR SUBSEQUENT OFFENSE.

$\begin{array}{c} 14 \\ 15 \end{array}$	(h) The citation shall be served on the defendant in accordance with the Maryland Rules.
16	(i) The citation shall contain:
17 18	(1) the certification by the State Board attesting to the truth of the matter set forth in the citation;
19	(2) the name and address of the person charged;
20	(3) the nature, time, and place of the violation;
21	(4) the manner in which the violation occurred;
22	(5) the amount of the penalty assessed;
23	(6) the manner, time, and location to pay the penalty;

$\frac{3}{4}$	(2) The written notice shall be given at least 5 days before the date of payment as set forth in the citation.
$5 \\ 6$	(k) (1) On receipt of the written notice of intent to stand trial, the State Board shall forward to the State Prosecutor a copy of the citation and the written notice.
7 8	(2) The State Prosecutor shall forward to the District Court having venue a copy of the citation and the written notice.
9	(3) On receipt of the citation and the written notice:

1 (A) (1) IN THIS SECTION, "INFLUENCE" MEANS TO USE PRESSURE, 2 DECEPTION, TRICKERY, OR DIRECT OR INDIRECT AUTHORITY TO INDUCE ACTION OR 3 TO CHANGE THE DECISION OR ACT OF ANOTHER.

4 (2) "INFLUENCE" INCLUDES THE DISSEMINATION OF FALSE 5 INFORMATION REGARDING THE TIME, PLACE, OR MANNER OF AN ELECTION, 6 REGARDLESS OF THE MEDIUM THROUGH WHICH THE FALSE INFORMATION IS 7 DISSEMINATED.

8 [(a)] (B) A person may not willfully and knowingly:

9 (1) (i) impersonate another person in order to vote or attempt to vote; 10 or

- (ii) vote or attempt to vote under a false name;

12 (2) vote more than once for a candidate for the same office or for the same13 ballot question;

14 (3) vote or attempt to vote more than once in the same election, or vote in 15 more than one election district or precinct;

16 (4) vote in an election district or precinct without the legal authority to vote
 17 in that election district or precinct;

18 (5) influence or attempt to influence a voter's voting decision through the 19 use of force, threat, menace, intimidation, bribery, reward, or offer of reward;

20 (6) influence or attempt to influence a voter's decision, through the use of 21 force, fraud, threat, menace, intimidation, bribery, reward, or offer of reward, whether to:

- (i) go to the polls to cast a vote; or

- (ii) vote by other lawful means; or

(7) engage in conduct that results or has the intent to result in the denial
or abridgement of the right of any citizen of the United States to vote on account of race,
color, or disability.

[(b)] (C) Except as provided in § 16–1002 of this title, a person who violates this section is guilty of a misdemeanor and on conviction is subject to a fine of not more than \$5,000 or imprisonment for not more than 5 years or both.
