## 1 AN ACT concerning

## State and Local Parks – Play Area Accessibility – Communication Boards Recreation Communication Boards Pilot Program

- 4 FOR the purpose of requiring the Department of Natural Resources and local governing 5 bodies to construct communication boards in certain newly constructed public play 6 areas under certain circumstances; authorizing the Department and local governing 7 bodies to construct communication boards when making alterations to certain 8 existing public play areas; providing for the funding of communication board 9 construction establishing the Maryland Recreation Communication Boards Pilot Program, subject to the availability of funding; altering the purpose and use of the 10 Park System Capital Improvements and Acquisition Fund; and generally relating to 11 play area communication boards. 12
