1 On or before November 30 each year, the Montgomery Commission shall issue (a) $\mathbf{2}$ a financial report for the previous fiscal year based on a certified audit. 3 The Montgomery Commission shall publish a summary of the financial report (b)in at least two newspapers of general circulation in the county. 4 $\mathbf{5}$ On or before December 15 each year, the Montgomery Commission shall (c)(1)6 publish on its website: 7 (i) the financial report issued under subsection (a) of this section; 8 and 9 (ii) a full and complete copy of the certified audit report for the 10 previous fiscal year. 11 (2)Subject to paragraph (3) of this subsection, in performing the duties 12required under paragraph (1) of this subsection, the Montgomery Commission shall publish all information in a public record that relates to a financial report or a certified audit report 13of which the Montgomery Commission is not specifically required to deny an inspection 14 15under the Public Information Act. 16 (3)Paragraph (2) of this subsection may not be construed as a waiver of 17information that is protected by privilege. 18 SECTION 2. AND BE IT FURTHER ENACTED, That Section(s) 16–111, 16–113, and 16-114 of Article - Housing and Community Development of the Annotated Code of 1920Maryland be renumbered to be Section(s) 16–110, 16–112, and 16–113, respectively. SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 2122October 1, 2024.
