1 AN ACT concerning

Department of Veterans Affairs – Renaming and Deputy Secretary of Military Family Policy and Programs

4 FOR the purpose of renaming the Department of Veterans Affairs to be the Department of Veterans and Military Families; renaming the Secretary of Veterans Affairs to be 5 6 the Secretary of Veterans and Military Families; requiring the Secretary to appoint 7 a Deputy Secretary of Military Family Policy and Programs; providing that the 8 Department of Veterans and Military Families is the successor of the Department of 9 Veterans Affairs; requiring the publisher of the Annotated Code of Maryland, in 10 consultation with the Department of Legislative Services, to correct cross-references and terminology in the Code that are rendered incorrect by this Act; and generally 11 relating to the renaming of the Department of Veterans Affairs and the Secretary of 12 Veterans Affairs. 13

- 5 (a) The Commission consists of the following members:
- 6 (1) the designee of the Secretary [of Veterans Affairs];
- 7 SECTION 2. AND BE IT FURTHER ENACTED, That, as provided in this Act:
- 8 (a) The Department of Veterans and Military Families is the successor of the 9 Department of Veterans Affairs.
- 10 (b) In every law, executive order, rule, regulation, policy, or document created by 11 an official, an employee, or a unit of this State, the names and titles of those agencies and 12 officials mean the names and titles of the successor agency or official.
 - SECTION 3. AND BE IT FURTHER ENACTED, That nothing in this Act affects the term of office of an appointed or elected member of any commission, office, department, agency, or other unit. An individual who is a member of a unit on the effective date of this Act shall remain for the balance of the term to which appointed or elected, unless the member sooner dies, resigns, or is removed under provisions of law.
 - SECTION 4. AND BE IT FURTHER ENACTED, That any transaction or employment status affected by or flowing from any change of nomenclature or any statute amended by this Act and validly entered into or existing before the effective date of this Act and every right, duty, or interest flowing from a statute amended by this Act remains valid after the effective date of this Act and may be terminated, completed, consummated, or enforced as required or allowed by any statute amended by this Act as though the amendment had not occurred. If a change in nomenclature involves a change in name or designation of any State unit, the successor unit shall be considered in all respects as having the powers and obligations granted the former unit.

SECTION 5. AND BE IT FURTHER ENACTED, That:

- 28 (a) The continuity of every commission, office, department, agency, or other unit 29 is retained.
- 30 (b) The personnel, records, files, furniture, fixtures, and other properties and all appropriations, credits, assets, liabilities, and obligations of each retained unit are continued as the personnel, records, files, furniture, fixtures, properties, appropriations, credits, assets, liabilities, and obligations of the unit under the laws enacted by this Act.
 - SECTION 6. AND BE IT FURTHER ENACTED, That letterhead, business cards, and other documents reflecting the renaming of the Department of Veterans Affairs to be

the Department of Veterans and Military Families may not be used until all letterhead, 1 2 business cards, and other documents already in print and reflecting the name of the 3 Department before the effective date of this Act have been used. SECTION 7. AND BE IT FURTHER ENACTED, That the publisher of the 4 Annotated Code of Maryland, in consultation with and subject to the approval of the 5 6 Department of Legislative Services, shall correct, with no further action required by the 7 General Assembly, cross-references and terminology rendered incorrect by this Act. The 8 publisher shall adequately describe any correction that is made in an editor's note following 9 the section affected. SECTION 8. AND BE IT FURTHER ENACTED, That this Act shall take effect July 10 1, 2024. 11 Approved:
