AN ACT concerning
Education – Public Libraries – Collective Bargaining (Library Workers Empowerment Act)
FOR the purpose of authorizing employees of certain public libraries to form, join, and participate in an employee organization and engage in certain other activities related to collective bargaining; requiring certain employers and certified exclusive representatives to engage in good faith bargaining; establishing a collective bargaining process for employees of certain public libraries; establishing a process for resolving impasses during collective bargaining; prohibiting employers and employee organizations from engaging in certain actions regarding the exercise of an employee's rights under this Act; prohibiting employers, employees, and employee organizations from engaging in certain actions related to strikes, work stoppages, boycotts, and lockouts; repealing certain provisions of law rendered obsolete by
