CHAPTER \_\_\_\_\_ AN ACT concerning Fishing and Hunting Licenses and Trout Stamps - Complimentary Licenses and Stamp Exemption – Veterans Determined to Be Unemployable FOR the purpose of authorizing the Department of Natural Resources to issue certain complimentary fishing and hunting licenses to certain veterans who the U.S. Department of Veterans Affairs determines are unemployable; exempting certain veterans who the U.S. Department of Veterans Affairs determines are unemployable from the requirement to obtain a trout stamp; and generally relating to fishing and hunting licenses and trout stamps.
