CHAPTER _____

1 AN ACT concerning

2 **Baltimore City – Control Over Powers of Police Commissioner**

3 FOR the purpose of repealing a prohibition on certain Baltimore City ordinances or acts of
4 certain municipal officials from conflicting, impeding, obstructing, hindering, or
5 interfering with the powers of the Baltimore City Police Commissioner; *making a*
6 *portion of this Act contingent on the passage and ratification, by a certain date, of a*
7 *certain Baltimore City Charter amendment*; and generally relating to the Baltimore
8 City Police Commissioner.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **The Charter of Baltimore City**

4 Article II – General Powers

5 The Mayor and City Council of Baltimore shall have full power and authority to
6 exercise all of the powers heretofore or hereafter granted to it by the Constitution of
7 Maryland or by any Public General or Public Local Laws of the State of Maryland; and in
8 particular, without limitation upon the foregoing, shall have power by ordinance, or such
9 other method as may be provided for in its Charter, subject to the provisions of said
10 Constitution and Public General Laws:

11 (27)

12 To have and exercise within the limits of Baltimore City all the power commonly
13 known as the Police Power to the same extent as the State has or could exercise that power
14 within the limits of Baltimore City]; provided, however, that no ordinance of the City or act
15 of any municipal officer, other than an act of the Mayor pursuant to Article IV of this
16 Charter, shall conflict, impede, obstruct, hinder or interfere with the powers of the Police
17 Commissioner].

18 SECTION 2. AND BE IT FURTHER ENACTED, That:

19 (a) Section 1 of this Act shall take effect contingent on the passage of an
20 amendment to the Charter of Baltimore City that provides for the appointment, terms of
21 office, and the powers and duties of the Baltimore City Police Commissioner and the powers
22 and duties of the Baltimore City Police Department and its ratification by the voters of
23 Baltimore City at the 2024 general election.

24 (b) If an amendment to the Charter of Baltimore City that provides for the
25 appointment, terms of office, and the powers and duties of the Baltimore City Police
26 Commissioner and the powers and duties of the Baltimore City Police Department is ratified
27 at the 2024 general election, Section 1 of this Act shall take effect January 1, 2025.

28 (c) If an amendment to the Charter of Baltimore City that provides for the
29 appointment, terms of office, and the powers and duties of the Baltimore City Police
30 Commissioner and the powers and duties of the Baltimore City Police Department is not
31 passed and ratified at the 2024 general election, Section 1 of this Act, with no further action
32 required by the General Assembly, shall be null and void.

33 SECTION ~~2~~ 3. AND BE IT FURTHER ENACTED, That, except as provided in
34 Section 2 of this Act, this Act shall take effect June 1, 2024.
