Advanced Practice Registered Nurses – Professional Liability Insurance Coverage – Notification Requirements

FOR the purpose of requiring advanced practice registered nurses practicing as an 4 advanced practice registered nurse in the State to notify patients in writing of certain 5 6 information relating to professional liability insurance coverage; requiring that the 7 notification be provided at certain visits and as part of certain informed consents, signed by a patient at certain times, and retained as part of the advanced practice 8 9 registered nurse's patient records; requiring each advanced practice registered nurse 10 practicing as an advanced practice registered nurse in the State who does not 11 maintain professional liability insurance coverage to post the information in a 12 certain location at the advanced practice registered nurse's place of practice; and 13 generally relating to advanced practice registered nurses and professional liability 14 coverage.

- 23 (3) RETAINED BY THE ADVANCED PRACTICE REGISTERED NURSE AS
- 24 PART OF THE ADVANCED PRACTICE REGISTERED NURSE'S PATIENT RECORDS.
- 25 (C) EACH ADVANCED PRACTICE REGISTERED NURSE PRACTICING AS AN
- 26 ADVANCED PRACTICE REGISTERED NURSE IN THE STATE WHO DOES NOT MAINTAIN
- 27 PROFESSIONAL LIABILITY INSURANCE COVERAGE SHALL POST THIS INFORMATION
- 28 IN A CONSPICUOUS LOCATION IN THE ADVANCED PRACTICE REGISTERED NURSE'S

- 31 shall develop appropriate language for the notification required under § 8–515 of the Health
- 32 Occupations Article as enacted by Section 1 of this Act.
