- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

16 (a) (1) Each county board shall provide for an annual audit of its financial 17 transactions and accounts.

18 (2) At the request of the Department, a county board shall conduct an audit
 19 under § 5–203 of this title.

20 (b) (1) The audit shall be made by a certified public accountant or a 21 partnership of certified public accountants who are:

- (i) Licensed by the State Board of Public Accountancy; and
