- 3 (1) County Commissioners;
- 4 (2) Board of Education;
- 5 (3) Board of Supervisors of Elections;
- 6 (4) Judges of the Orphans' Court; AND
- 7 (5) Liquor Control Board[; and
- 8 (6) Sheriff.
- 9 (B) The Commission may recommend to the County Commissioners an increase 10 or decrease in the salary of the State's Attorney, or any office in division (A) of this section.
- 11 (C) The Commission shall report its recommendations to the County 12 Commissioners on or before June 30, 1997, and on or before June 30 every fourth year 13 thereafter.
 - SECTION 2. AND BE IT FURTHER ENACTED, That, in accordance with <u>pursuant</u> <u>to</u> Article III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary or compensation of the Sheriff of Garrett County while serving in a term of office beginning before the effective date of this Act, but the provisions of this Act concerning the salary or compensation of the Sheriff of Garrett County shall take effect at the beginning of the next following term of office. This limitation does not apply to an individual appointed or elected after the effective date of this Act to fill out an unexpired term.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2024.
