Natural Resources - Hunting - Tundra Swans

- 3 FOR the purpose of requiring the Department of Natural Resources to establish an annual 4 tundra swan hunting season if authorized by federal law; requiring the Department $\mathbf{5}$ to request that the U.S. Fish and Wildlife Service authorize an annual tundra swan 6 hunting season in the State and provide the Department with a certain number of 7 permits to take tundra swan annually; requiring the Department to distribute 8 tundra swan permits annually using a lottery-based system and to charge a certain 9 permit application fee under certain circumstances; and generally relating to 10 hunting.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

20 (a) (1) Pursuant to § 10–205 of this title, the Department shall establish by 21 regulation and publish by July 1 each year the open season to hunt forest and upland game 22 birds and mammals.

(2) Except as provided under § 10–410 of this subtitle, the Department may
 not authorize hunting on a Sunday.

24 25 26 27 28 29	(c) The Department shall establish by regulation the maximum open season for hunting crows which is permissible under federal law, and shall include in its regulations such provisions as are permitted under federal law for control of crows at any time they are found to be committing or about to commit depredation upon ornamental or shade trees, agricultural crops, livestock or wildlife, or when concentrated in such numbers and manner as to constitute a health hazard or other nuisance.

2 (I) AUTHORIZE AN ANNUAL TUNDRA SWAN HUNTING SEASON IN 3 THE STATE; AND

4 (II) PROVIDE THE DEPARTMENT WITH THE NUMBER OF 5 PERMITS TO TAKE TUNDRA SWAN ANNUALLY FOR WHICH THE DEPARTMENT IS 6 ELIGIBLE.

7 (3) IF THE U.S. FISH AND WILDLIFE SERVICE PROVIDES THE 8 DEPARTMENT WITH PERMITS TO TAKE TUNDRA SWAN, THE DEPARTMENT SHALL:

9 (I) DISTRIBUTE THE PERMITS ANNUALLY USING A 10 LOTTERY-BASED SYSTEM; AND

11(II)CHARGE A PERMIT APPLICATION FEE FOR THE TUNDRA12SWAN HUNTING PERMIT LOTTERY IN AN AMOUNT DETERMINED BY THE13DEPARTMENT.

14(4)(1)APERSON MAY NOT HUNT TUNDRA SWAN WITHOUT15OBTAINING A PERMIT FROM THE DEPARTMENT.

16 (II) A PERSON WHO HARVESTS A TUNDRA SWAN SHALL REPORT 17 THE INFORMATION TO THE DEPARTMENT ON A FORM PROVIDED BY THE 18 DEPARTMENT.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July20 1, 2024.
