# Correctional Officers' Retirement System – Membership

3 FOR the purpose of altering membership in the Correctional Officers' Retirement System to include certain employees of the Department of Public Safety and Correctional 4  $\mathbf{5}$ Services and the Maryland Department of Health; making members transferred to 6 the Correctional Officers' Retirement System under this Act eligible to receive 7 creditable service for unused sick leave accrued by the member in the State Employees' Retirement System or State Employees' Pension System; providing for 8 9 the calculation of a certain benefit from the Correctional Officers' Retirement System 10 for individuals serving in certain positions on or before a certain date; requiring the 11 State Retirement and Pension System to transfer the creditable service of employees 12 transferred into the Correctional Officers' Retirement System under this Act unless 13the employee elects; authorizing certain employees to elect not to transfer service to the Correctional Officers' Retirement System on or before a certain date; requiring 14 the Board of Trustees for the State Retirement and Pension System to calculate a 15certain disability benefit for certain individuals and to grant a certain benefit under 1617certain circumstances; and generally relating to membership in the Correctional 18 Officers' Retirement System.

(b) If an individual described under subsection (a) of this section is granted an
ordinary disability benefit under Title 29, Subtitle 1 of the State Personnel and Pensions
Article, the Board of Trustees for the State Retirement and Pension System shall calculate
the ordinary disability benefit under §§ 29–106 and 29–108 of the State Personnel and
Pensions Article and grant the greater benefit to the individual.

SECTION 5. 6. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2024. Section 3 of this Act shall remain effective for a period of 1 year and, at the end of June 30, 2025, Section 3 of this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
