1 AN ACT concerning

2 Education – Blind and Visually Impaired Students – Textbook Equity

3 FOR the purpose of requiring establishing requirements for each county board of education, 4 on or before a certain date each year, to determine regarding the provision of the instructional materials that will be used in the upcoming school year for certain $\mathbf{5}$ 6 students; requiring the county board to coordinate with the Instructional Resources 7 Center within the State Department of Education to provide instructional materials 8 in a specialized format to blind or visually impaired students not later than a certain 9 day in the upcoming school year; requiring the Department to cover the cost to 10 produce certain instructional materials that are not available in a specialized format; 11 requiring certain textbook publishers to provide an electronic file of certain textbooks

- 21SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 22That the Laws of Maryland read as follows:

- "Braille" means the system of reading and writing through touch 26(3)commonly known as Standard English Contracted Braille. 27

- (4)"Child who is blind or visually impaired" means a child who:

29Has a visual acuity of 20/200 or less in the better eye with (i) correcting lenses or has a limited field of vision so that the widest diameter of the visual 30 31 field subtends an angle no greater than 20 degrees;

Has a medically indicated expectation of visual deterioration; or (ii)

33 Has a medically diagnosed limitation in visual functioning that (iii) restricts the child's ability to read and write standard print at levels expected of other 3435children of comparable ability and grade level.

1 (5) "Individualized education program" and "IEP team" have the same 2 meaning as provided by the Individuals with Disabilities Education Act.

3 (6) "National Instructional Materials Access Center" means the center 4 established under § 674(e) of the federal Individuals with Disabilities Education 5 Improvement Act of 2004.

6 (7) "NIMAS" means the National Instructional Materials Accessibility 7 Standard established by the federal Secretary for Education under 20 U.S.C. 1412 to be 8 used in the preparation of electronic files suitable and used solely for efficient conversion 9 into specialized formats.

10 (9) "Print instructional materials" means printed textbooks and related 11 printed core materials that are written and published primarily for use in elementary 12 school and secondary school instruction and are required by the Department or county 13 board for use by students in the classroom.

14 (10) "Specialized formats" means braille, large print, audio, or digital text 15 that is used by blind or visually impaired individuals.

16 (b) (1) In developing the individualized education program for a child who is 17 blind or visually impaired, provisions shall be made for instruction in braille and the use of 18 braille unless the IEP team determines, after an evaluation of the child's reading and 19 writing skills, needs, and appropriate reading and writing media, including an evaluation 20 of the child's future needs for instruction in braille or the use of braille, that such 21 instruction or use is not appropriate for the child.

(i) A child may not be denied the opportunity for instruction inbraille reading and writing solely because the child has some remaining vision.

(ii) This section does not require the exclusive use of braille if other
reading and writing media are appropriate to the child's educational needs. The use of other
reading and writing media does not preclude the use of braille or the instruction of braille.

(2) For the purpose of achieving successful implementation of this
 subsection, the State Board and the Professional Standards and Teacher Education Board
 shall adopt certification standards for teachers of blind and visually impaired students.

30 (3) (i) The Department shall collaborate with and provide support to 31 the Instructional Resources Center to develop procedures to coordinate the statewide 32 availability of textbooks and supplementary instructional materials that may be accessed 33 using specialized formats that use NIMAS.

(ii) 1. The procedures developed under subparagraph (i) of this
 paragraph shall require the Department and a county board to include, in any procurement

1 contract or other document or agreement used to purchase print instructional materials2 from a publisher, a provision that requires the publisher to:

A. On or before the delivery of the print instructional materials, prepare and provide the National Instructional Materials Access Center electronic files containing the contents of the print instructional materials using NIMAS; or

B. Purchase instructional materials from that publisher that
are produced in, or may be rendered in, specialized formats.

9 2. A publisher may not be required to provide an electronic 10 copy of any instructional material copyrighted before July 1, 2007.

(iii) The State Board shall coordinate with the National Instructional
 Materials Access Center to facilitate the timely transfer to the Instructional Resources
 Center of:

14 1. Electronic files or instructional materials sent by 15 publishers for the Instructional Resources Center to convert the instructional materials 16 into specialized formats; and

17 2. Electronic files or instructional materials purchased from
18 a publisher in a specialized format.

(iv) Beginning on July 1, 2007, the Instructional Resources Center
 shall make reasonable efforts to provide the instructional materials in specialized formats
 to students who are blind or visually impaired for use on the first day of classes each year
 or in a timely manner.

JANUARY MARCH 15 THEREAFTER, EACH COUNTY BOARD SHALL DETERMINE THE
