BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Local Government **12-905.** THIS SECTION APPLIES ONLY TO ANNE ARUNDEL COUNTY. (A) (B) **(1)** IF A PERSON FAILS TO OBEY A SUBPOENA SERVED BY THE ANNE

1	(1) THE INDIVIDUAL AUTHORIZING THE SERVICE OF THE SUBPOENA
2	MAY AUTHORIZE THE INDIVIDUAL SERVING THE SUBPOENA TO CERTIFY THE

- 16 <u>1. AFTER NOTICE TO THE PERSON SUBPOENAED AS A</u>
  17 <u>WITNESS OR DIRECTED TO PRODUCE BOOKS, PAPERS, RECORDS, ELECTRONICALLY</u>
  18 <u>STORED INFORMATION, DOCUMENTS, AND TANGIBLE PROPERTY; AND</u>
- 2. ON A FINDING THAT THE ATTENDANCE AND TESTIMONY OF THE WITNESS OR THE PRODUCTION OF THE BOOKS, PAPERS, RECORDS, ELECTRONICALLY STORED INFORMATION, DOCUMENTS, AND TANGIBLE PROPERTY IS RELEVANT OR NECESSARY FOR THE PROCEEDINGS OF THE COMMISSION.
- 24 (2) AN ORDER ISSUED BY THE COURT UNDER THIS SUBSECTION
  25 SHALL BE SERVED ON THE PERSON TO WHOM IT IS DIRECTED BY THE SHERIFF OR
  26 DEPUTY SHERIFF.
- 27 (3) A FAILURE TO OBEY AN ORDER ISSUED BY THE COURT UNDER
  28 THIS SUBSECTION MAY BE PUNISHED BY THE COURT AS CONTEMPT OF COURT.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 30 October 1, 2024.
