CHAPTER
AN ACT concerning
Condominiums - Mandatory Insurance Coverage - Detached Units
FOR the purpose of altering the types of elements and units for which a council of unit owners is required to maintain certain property insurance; requiring the council of unit owners to notify owners of detached units within a condominium of certain property insurance coverage obligations; limiting instances when an owner of a detached unit within a condominium is required to carry homeowners insurance on the entirety of the unit; authorizing a council of unit owners to carry homeowners insurance on the entirety of all units located within a certain condominium; and generally relating to mandatory insurance coverage for condominiums.

- 2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 3 That the Laws of Maryland read as follows:
- 4 Article Real Property
- 5 11-114.
- 6 (a) Commencing not later than the time of the first conveyance of a unit to a person other than the developer, the council of unit owners shall maintain, to the extent 8 reasonably available:
- 9 (1) Property insurance against risks of direct physical loss commonly 10 insured against in amounts determined by the council of unit owners, but not less than any 11 amounts specified in the declaration or bylaws:
- 12 (i) For attached [or] UNITS, multifamily dwelling units, OR
 13 DETACHED UNITS LOCATED WITHIN A CONDOMINIUM NOT COMPOSED ENTIRELY OF
 14 SIMILAR DETACHED UNITS, on the common elements and units, exclusive of
 15 improvements and betterments installed in units by unit owners other than the developer;
- 16 and
- 17 (ii) For detached units LOCATED WITHIN A CONDOMINIUM 18 COMPOSED ENTIRELY OF SIMILAR DETACHED UNITS, on the common elements; and
- 19 (2) Comprehensive general liability insurance, including medical payments insurance, in an amount determined by the council of unit owners, but not less than any amount specified in the declaration or bylaws, covering occurrences commonly insured against for death, bodily injury, and property damage arising out of or in connection with the use, ownership, or maintenance of the common elements.
- 24 (b) (1) The council of unit owners shall give notice to all unit owners of the termination of any insurance policy within 10 days of termination.
- 26 (II) The declaration or bylaws may require the council of unit owners to carry any other insurance, and the council of unit owners in any event may carry any other insurance it deems appropriate to protect the council of unit owners or the unit owners.
- 30 (2) (I) THE COUNCIL OF UNIT OWNERS SHALL GIVE AN ANNUAL
 31 NOTICE, IN WRITING, OF ANY OBLIGATION OF AN OWNER OF A RESIDENTIAL,
 32 DETACHED UNIT TO OBTAIN PROPERTY INSURANCE COVERAGE ON THE UNIT.

(II) IF THERE IS A CHANGE IN ANY OBLIGATION UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE COUNCIL OF UNIT OWNERS SHALL PROMPTLY PROVIDE THE UNIT OWNER WITH AN UPDATED NOTICE.

- (c) Insurance policies carried pursuant to subsection (a) of this section shall provide that:
- (1) Subject to the applicable coverage specified under subsection (a)(1) of this section, each unit owner is an insured person under the policy with respect to liability arising out of the unit owner's ownership of an undivided interest in the common elements or membership in the council of unit owners for property and casualty losses to the common elements and the units, exclusive of improvements and betterments installed in the units by unit owners other than the developer;
- 12 (2) The insurer waives its right to subrogation under the policy against any unit owner of the condominium or members of his household;
- 14 (3) An act or omission by any unit owner, unless acting within the scope of 15 his authority on behalf of the council of unit owners, does not void the policy and is not a 16 condition to recovery under the policy; and
- 17 (4) If, at the time of a loss under the policy, there is other insurance in the 18 name of a unit owner covering the same property covered by the policy, the policy is primary 19 insurance not contributing with the other insurance.
 - (d) (1) Subject to the applicable coverage specified under subsection (a)(1) of this section, any loss covered by the property policy shall be adjusted with the council of unit owners, but the insurance proceeds for that loss shall be payable to any insurance trustee designated for that purpose, or otherwise to the council of unit owners, and not to any mortgagee.
- 25 (2) The insurance trustee or the council of unit owners shall hold any 26 insurance proceeds in trust for unit owners and lien holders as their interests may appear.
- (3) (i) Subject to the provisions of subsection (g) of this section, the proceeds shall be disbursed first for the repair or restoration of the damaged common elements and, for condominiums with attached [or] UNITS, multifamily units, OR DETACHED UNITS LOCATED WITHIN A CONDOMINIUM NOT COMPOSED ENTIRELY OF SIMILAR DETACHED UNITS that must maintain a property insurance policy on the units, the damaged units.
- 33 (ii) Unit owners and lien holders are not entitled to receive payment 34 of any portion of the proceeds unless:
- There is a surplus of proceeds after the common elements and, for condominiums with attached [or] UNITS, multifamily units, OR DETACHED UNITS

- 1 LOCATED WITHIN A CONDOMINIUM NOT COMPOSED ENTIRELY OF SIMILAR
 2 DETACHED UNITS that must maintain a property insurance policy on the units, the units
- 3 have been completely repaired or restored; or
- 4 2. The condominium is terminated.
- 5 (e) (1) An insurance policy issued to the council of unit owners does not 6 prevent a unit owner from obtaining insurance for his own benefit.
- 7 (2) An UNLESS A COUNCIL OF UNIT OWNERS EXERCISES THE
 8 AUTHORITY UNDER PARAGRAPH (3) OF THIS SUBSECTION, AN owner of a residential,
 9 detached unit, unit LOCATED WITHIN A CONDOMINIUM COMPOSED ENTIRELY OF
 10 SIMILAR DETACHED UNITS, shall carry homeowners insurance coverage on the entirety
 11 of the unit.
- 12 (3) A COUNCIL OF UNIT OWNERS MAY CARRY HOMEOWNERS

- 15 (f) (1) An insurer that has issued an insurance policy under this section shall 16 issue certificates or memoranda of insurance to the council of unit owners and, upon 17 request, to any unit owner, mortgagee, or beneficiary under a deed of trust.
- 18 (2) An insurer may cancel an insurance policy issued under this section in accordance with § 27–603 of the Insurance Article.
- 20 (g) (1) Subject to the applicable coverage specified under subsection (a)(1) of this section, any portion of the common elements and the units, exclusive of improvements and betterments installed in the units by unit owners other than the developer, damaged or destroyed shall be repaired or replaced promptly by the council of unit owners unless:
- 24 (i) The condominium is terminated;
- 25 (ii) Repair or replacement would be illegal under any State or local 26 health or safety statute or ordinance; or
- 27 (iii) 80 percent of the unit owners, including every owner of a unit or assigned limited common element which will not be rebuilt, vote not to rebuild.
- 29 (2) (i) 1. The cost of repair or replacement in excess of insurance 30 proceeds and reserves is a common expense.
- 31 2. A property insurance deductible is not a cost of repair or replacement in excess of insurance proceeds.

(h) The council of unit owners shall maintain and make available for inspection a copy of all insurance policies maintained by the council of unit owners.
(i) The provisions of this section do not apply to a condominium all of whose units are intended for nonresidential use.
