BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article - Environment

- 1 5-503.
- 2 (a) (1) A person shall obtain, on written application to the Department, a 3 permit from the Department to:
- 4 (i) Construct, reconstruct, or repair any reservoir, dam, or 5 waterway obstruction;
- 6 (ii) Make, construct, or permit to be made or constructed any change 7 or addition to any reservoir, dam, or waterway obstruction;
- 8 (iii) Make or permit to be made any change in, addition to, or repair 9 of any existing waterway obstruction; or
- 10 (iv) Change, in any manner, in whole or part the course, current, or cross section of any stream or body of water within the State, except tidal waters.
- 12 (b) (1) A person is exempt from the requirement of obtaining a permit from the 13 Department if:
- 14 (i) The plans and specifications are approved by the appropriate soil conservation district or the Department's designee;
- 16 (ii) [The pond is not located within drainage of the Gwynns Falls, 17 Jones Falls, or Herring Run streams situated in or adjacent to Baltimore City;
- 18 (iii)] The pond meets minimum standards for safety set forth in 19 Department rules and regulations;
- 20 [(iv)] (III) The contributory drainage area is less than 1 square mile 21 (640 acres);
- [(v)] (IV) The dam is not greater than 20 feet in height measured vertically from the lowest point on the top of the dam to the lowest point on the upstream toe of the dam;
- 25 **[(vi)] (V)** The pond is a low hazard structure the failure of which is unlikely to cause loss of life or property damage; and
- [(vii)] (VI) The pond is not a wastewater stabilization pond.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2024.
