$\frac{3}{4}$	(ii) Make, construct, or permit to be made or constructed any change or addition to any reservoir, dam, or waterway obstruction;

17 18	[(iv)] (III) The contributory drainage area is less than 1 square mile (640 acres);

24	[(vii)] (VI) The pond is not a wastewater stabilization pond.
