- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
  That the Laws of Maryland read as follows:
- 18Article Transportation
- 19 8–601.

## 20 (a) IN THIS SECTION, "DEVELOPMENT PROJECT" MEANS A PUBLIC OR 21 PRIVATE CONSTRUCTION PROJECT THAT REQUIRES APPROVAL FROM THE 22 ADMINISTRATION FOR ACCESS TO A STATE HIGHWAY FOR INGRESS OR EGRESS.

23 (B) The Administration shall construct, reconstruct, and repair State highways

 $\mathbf{2}$ [(b)] (C) (1) The Department may not spend any further funds for the 3 construction of I-95 through Prince George's County that will involve a new or 4 reconstructed segment connecting it to any other highway in Prince George's County. The  $\mathbf{5}$ Department may not spend any further funds for the construction of a new highway, 6 arterial, freeway, or expressway in the lands between Viers Mill Road and Northwest 7 Branch described in the 1980 highway needs inventory as the right-of-way reserved for 8 the Rockville Facility in Montgomery County, including the area designated as the 9 Matthew Henson State Park under § 5–1004 of the Natural Resources Article.

10 [(c)] (2) This prohibition does not preclude construction in the right-of-way 11 designated as the Rockville Facility of:

12[(1)](I)Roadway crossings to facilitate traffic flow and highway safety;13or

14 [(2)] (II) A hiker/biker trail in the lands between Viers Mill Road and 15 Northwest Branch.

#### 16 (D) THE ADMINISTRATION SHALL PROVIDE COMMENTS ON AN 17 APPLICATION FOR A DEVELOPMENT PROJECT WITHIN **30** DAYS AFTER THE 18 ADMINISTRATION RECEIVES THE COMPLETE PROJECT APPLICATION.

At the request of any proper county agency, the Administration shall provide to the county engineering advice and information on the county's road program, including its farm-to-market road program. The Administration may not charge the cost of this advice or information either to the county, to the county's share of highway user revenues, or to other funds allocated to the county.
