AND BE IT FURTHER ENACTED, That the proceeds of bonds issued 17 on July 6, 2023, as the Series 2023B Bonds for the Camden Yards football sports facility 18 and currently held by the State Treasurer shall be transferred as follows: 19 \$5,000,000 to the Camden Yards Football Sports Facility Capital Works 20 Fund established under § 10–652.3 of the Economic Development Article, as enacted by 21 Section 1 of this Act; and 22 \$5,000,000 to the Camden Yards Football Sports Facility Emergency 23Repair Fund established under § 10–652.4 of the Economic Development Article, as enacted 24by Section 1 of this Act.
