# Maryland Center for School Safety – Firearm Detection Platforms – Evaluation (Maryland Firearm Detection Platform Act)

FOR the purpose of requiring the Maryland Center for School Safety, in collaboration with
certain public safety and educational institutions, to conduct an evaluation of
firearm detection platforms; authorizing funds from the Safe Schools Fund to be used
to assist local school systems in the procurement and maintenance of firearm
detection platforms; and generally relating to the Maryland Center for School Safety
and firearm detection platforms.
