# Maryland Community Health Resources Commission – Sunset Extension and Program Evaluation

4 FOR the purpose of adding the Maryland Community Health Resources Commission to the governmental activities and units subject to the Maryland Program Evaluation Act;  $\mathbf{5}$ 6 extending the termination date for certain provisions of law related to the 7 Commission; stating that it is the intent of the General Assembly that the Office of 8 Program Evaluation and Government Accountability in the Department of Legislative Services conduct an evaluation of the Commission on or before a certain 9 date; and generally relating to the Maryland Community Health Resources 10 11 Commission.

# Chapter 280 of the Acts of 2005, as amended by Chapter 21 of the Acts of 2006, Chapters 624 and 625 of the Acts of 2008, and Chapter 368 of the Acts of 2014

5 SECTION 14. AND BE IT FURTHER ENACTED, That, subject to Section 13 of this 6 Act, this Act shall take effect July 1, 2005. Section 3 of this Act shall remain effective for a 7 period of [20] **23** <u>30</u> years and, at the end of June 30, [2025] **2028** <u>2035</u>, with no further 8 action required by the General Assembly, Section 3 of this Act shall be abrogated and of no 9 further force and effect. Section 5 of this Act shall remain effective for a period of 2 years 10 and, at the end of June 30, 2007, with no further action required by the General Assembly, 11 Section 5 of this Act shall be abrogated and of no further force and effect.

12 SECTION 3. AND BE IT FURTHER ENACTED, That it is the intent of the General 13 Assembly that, on or before January 1, 2025, the Office of Program Evaluation and 14 Government Accountability in the Department of Legislative Services shall conduct an 15 evaluation of the Maryland Community Health Resources Commission.

16 SECTION 4. <u>3.</u> AND BE IT FURTHER ENACTED, That this Act shall take effect 17 July 1, 2024.
