BY repealing and reenacting, without amendments, Article – Transportation Section 12–301(a) Annotated Code of Maryland (2020 Replacement Volume and 2023 Supplement) BY repealing and reenacting, with amendments, Article – Transportation Section 12-301(b), 16-105(e), and 16-115(d) Annotated Code of Maryland (2020 Replacement Volume and 2023 Supplement)

25 26 27	(e) (1) This subsection only applies to an individual who holds a license and who seeks a different class license to drive a motor vehicle that, under the individual's current license, the individual is not authorized to drive.
28 29	(2) The holder of a learner's instructional permit may not take the driver's license examination sooner than 14 days after the permit is issued.

The 14 days' requirement may be waived if a subsequent learner's

instructional permit is issued or applied for.

- 1 (4) A learner's instructional permit issued to an individual described in 2 paragraph (1) of this subsection expires [180 days] 1 YEAR after THE date of issuance.

- 6 (d) (1) A license [held by a member of the armed forces of the United States

- 19 **2.** A DEPENDENT OF THE CONTRACT EMPLOYEE WHO IS 20 RESIDING WITH THE CONTRACT EMPLOYEE OUTSIDE THE STATE.
- 21 (2) The license also shall remain in effect, if it would otherwise have expired under this section, for a period of 30 days following the date of the licensee's return to this State, or the member's discharge or separation from active service:
- 24 (i) If the licensee has in the licensee's immediate possession, 25 together with the licensee's driver's license, papers indicating the member's active service 26 outside this State or the member's discharge or separation; and
- 27 (ii) If the license is not otherwise suspended, revoked, or canceled 28 under this title during the 30-day period.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 30 October 1, 2024.
