- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

25 26	(2) The State Treasurer shall hold the Fund separately, and the Comptroller shall account for the Fund.

28	(1) money appropriated in the State budget to the Fund;
29	(2) interest earnings of the Fund; and

3 (g) (1)The Fund may be used only to provide grants and loans to anchor 4 institutions for community development projects in SUSTAINABLE COMMUNITIES AND $\mathbf{5}$ blighted areas of the State. 6 (2)To be eligible for a grant or loan, an anchor institution shall provide 7evidence of matching funds [from a private source]. 8 The Department shall award grants and loans from the Fund on a (3)9 competitive basis. 10 (h)(1)The State Treasurer shall invest the money of the Fund in the same 11 manner as other State money may be invested. Any interest earnings of the Fund shall be credited to the Fund. 12(2)Expenditures from the Fund may be made only in accordance with the State 13(i) budget. 1415For fiscal year 2019, the Governor shall include in the annual budget (i) (1)16 bill or the capital budget bill an appropriation of \$4,000,000 to the Fund. 17(2)For fiscal year 2020, the Governor shall include in the annual budget bill or the capital budget bill an appropriation of \$5,000,000 for the Fund. 18 For fiscal year 2021, the Governor shall include in the annual 19 (3)(i) 20budget bill or the capital budget bill an appropriation of \$5,000,000 for the Fund. 21For fiscal year 2022 and each fiscal year thereafter, the Governor (ii) 22shall include in the annual budget bill or the capital budget bill an appropriation of \$10,000,000 for the Fund. 23246-205.

(a) The Smart Growth Subcabinet, on the recommendation of the Secretary, may
designate an area as a sustainable community if the sponsor demonstrates that past and
current trends in homeownership, property values, commercial and residential vacancy,
and business or housing investment show a need for reinvestment in the area and if:

(1) entities in the community, such as local governments, employers, educational institutions, civic organizations, community organizations, or cultural organizations, support the proposed sustainable community plan and have pledged resources to develop or implement it;

(2) the proposed sustainable community plan addresses the need for

$\frac{1}{2}$	reinvestment in the area and will enhance the area, and give individuals of different incomes a range of housing options, employment opportunities, and other amenities;

5	(4) the proposed area is near a town center or a transportation center;
