A BILL ENTITLED

1 AN ACT concerning

2 **Court Personnel – Protection of Personal Information**
3 **(Judge Andrew F. Wilkinson Judicial Security Act)**

4 FOR the purpose of authorizing a certain protected individual or the Office of Information
5 Privacy in the Administrative Office of the Courts to request that a governmental
6 entity or person not publish personal information of the individual on the Internet,
7 social media, or social networks or that the governmental entity or person remove
8 the information from any existing publication; specifying certain procedures for the
9 protection of personal information of a protected individual; authorizing certain
10 relief for a violation of this Act; establishing a criminal penalty for publicly posting
11 personal information of a protected individual under certain circumstances;
12 establishing the Judicial Address Confidentiality Program; establishing the Task
13 Force to Ensure the Safety of Judicial Facilities; and generally relating to court
14 personnel and the protection of personal information.

Preamble

WHEREAS, Judge Andrew F. Wilkinson was appointed to the Circuit Court for Washington County in January 2020, and served the Maryland Judiciary and the citizens of this State with distinction until his untimely death on October 19, 2023; and

WHEREAS, On October 19, 2023, Judge Wilkinson calmly and even-handedly presided over a divorce and custody case involving extensive testimony of abuse inflicted on one of the litigants and her children; and

WHEREAS, Judge Wilkinson should have been able to peacefully return home to his family in Hagerstown after having appropriately met his professional obligations; and

WHEREAS, Judge Wilkinson left the courthouse after issuing his ruling and was shot and killed in the driveway of his personal residence by the abusive litigant over whose case he had just presided; and

WHEREAS, Protecting the safety and security of judicial officers throughout Maryland and the United States has become an issue of critical importance due to threats, assaults, and murders of judicial officers and their family members; and

WHEREAS, The National Center for State Courts reports Judge Wilkinson's murder as the third targeted shooting of a state court judge in the last 3 years; and

WHEREAS, The United States Congress passed the Daniel Anderl Judicial Security and Privacy Act in 2020, after an aggrieved litigant murdered U.S. District Judge Esther Salas's only son at her personal residence; and

WHEREAS, The General Assembly acknowledges these increasing threats to judicial officers and seeks to ensure the protection, safety, and security of judicial officers and their families throughout Maryland; now, therefore,

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

17 (XIII) A SCHOOL OR DAYCARE;

18 (XIV) A PLACE OF WORSHIP; OR

19 (XV) A PLACE OF EMPLOYMENT.

2 **PART OF A NEWS STORY, COMMENTARY, AN EDITORIAL, OR ANY OTHER SPEECH ON**
3 **MATTERS OF PUBLIC CONCERN.**

4 **(E) “PROTECTED INDIVIDUAL” MEANS:**

5 **(1) A CURRENT OR RETIRED JUSTICE OR JUDGE OF A COURT**
6 **ESTABLISHED UNDER ARTICLE IV OF THE MARYLAND CONSTITUTION;**

7 **(2) A CURRENT OR RETIRED JUSTICE OR JUDGE OF A FEDERAL**
8 **COURT, INCLUDING A U.S. BANKRUPTCY COURT, DOMICILED IN THE STATE;**

9 **(3) A CURRENT OR RETIRED MAGISTRATE APPOINTED BY A CIRCUIT**
10 **COURT OF THE STATE;**

11 **(4) A CURRENT OR RETIRED UNITED STATES MAGISTRATE JUDGE**
12 **DOMICILED IN THE STATE;**

13 **(5) A CURRENT OR RETIRED COMMISSIONER OF THE DISTRICT**

18 **(F) “PUBLISH” MEANS TO POST OR OTHERWISE MAKE AVAILABLE TO THE**
19 **GENERAL PUBLIC ON THE INTERNET, SOCIAL MEDIA, OR SOCIAL NETWORKS.**

27 **INFORMATION FROM ANY EXISTING PUBLICATION.**

28 **(B) A REQUEST MADE UNDER THIS SECTION SHALL:**

29 **(1) BE IN WRITING;**

1 **(2) BE SENT BY CERTIFIED MAIL OR BY E-MAIL;**

2 **(3) EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION,**
3 **PROVIDE SUFFICIENT INFORMATION TO CONFIRM THAT THE REQUESTER IS A**
4 **PROTECTED INDIVIDUAL; AND**

5 **(4) ADEQUATELY IDENTIFY THE DOCUMENT, POSTING, OR OTHER**
6 **PUBLICATION CONTAINING THE PERSONAL INFORMATION.**

7 **(C) A REQUEST MADE BY THE OFFICE OF INFORMATION PRIVACY**
8 **CERTIFIES THAT A REQUESTER IS A PROTECTED INDIVIDUAL AND NO FURTHER**
9 **INFORMATION MAY BE REQUIRED TO CONFIRM THAT THE REQUESTER IS A**
10 **PROTECTED INDIVIDUAL.**

11 **(D) ON RECEIPT OF A REQUEST UNDER SUBSECTION (B) OF THIS SECTION,**
12 **A GOVERNMENTAL ENTITY SHALL PROMPTLY ACKNOWLEDGE RECEIPT OF THE**
13 **REQUEST IN WRITING BY CERTIFIED MAIL OR BY E-MAIL AND:**

14 **(1) TAKE STEPS REASONABLY NECESSARY TO ENSURE THAT THE**
15 **PERSONAL INFORMATION IS NOT PUBLISHED; OR**

16 **(2) IF THE PERSONAL INFORMATION IS ALREADY PUBLISHED,**
17 **PROVIDE FOR THE REMOVAL OF THE PERSONAL INFORMATION WITHIN 72 HOURS**
18 **AFTER RECEIPT OF THE REQUEST.**

19 **(E) A PROTECTED INDIVIDUAL OR THE OFFICE OF INFORMATION PRIVACY**
20 **MAY BRING AN ACTION FOR A VIOLATION OF THIS SECTION AGAINST A**

5 **PROVIDE SUFFICIENT INFORMATION TO CONFIRM THAT THE REQUESTER IS A**
6 **PROTECTED INDIVIDUAL; AND**

7 **(4) ADEQUATELY IDENTIFY THE DOCUMENT, POSTING, OR OTHER**
8 **PUBLICATION CONTAINING THE PERSONAL INFORMATION.**

9 **(C) A REQUEST MADE BY THE OFFICE OF INFORMATION PRIVACY**
10 **CERTIFIES THAT A REQUESTER IS A PROTECTED INDIVIDUAL AND NO FURTHER**
11 **INFORMATION MAY BE REQUIRED TO CONFIRM THAT THE REQUESTER IS A**
12 **PROTECTED INDIVIDUAL.**

13 **(D) THE PERSON TO WHOM THE REQUEST IS MADE SHALL:**

14 **(1) PROVIDE FOR THE REMOVAL OF THE PERSONAL INFORMATION**
15 **WITHIN 72 HOURS AFTER RECEIPT OF THE REQUEST; AND**

16 **(2) NOTIFY THE PROTECTED INDIVIDUAL OR THE OFFICE OF**
17 **INFORMATION PRIVACY BY CERTIFIED MAIL OR BY E-MAIL OF THE REMOVAL.**

18 **(E) (1) A PROTECTED INDIVIDUAL OR THE OFFICE OF INFORMATION**
19 **PRIVACY MAY BRING AN ACTION FOR A VIOLATION OF THIS SECTION AGAINST A**
20 **PERSON FOR:**

21 **(i) DECLARATORY RELIEF;**

22 **(ii) INJUNCTIVE RELIEF;**

23 **(iii) DAMAGES INCURRED AS THE RESULT OF A VIOLATION OF**
24 **THIS SECTION; OR**

25 **(iv) REASONABLE ATTORNEY'S FEES.**

26 **(2) IN ADDITION TO THE RELIEF PROVIDED UNDER PARAGRAPH (1)**
27 **OF THIS SUBSECTION, IF A COURT FINDS THAT A PERSON WILLFULLY REFUSED TO**

5 INFORMATION OF A PROTECTED INDIVIDUAL IF:

6 (1) THE PERSON KNOWS OR REASONABLY SHOULD KNOW THAT
7 PUBLISHING THE PERSONAL INFORMATION POSES AN IMMINENT AND SERIOUS
8 THREAT TO THE PROTECTED INDIVIDUAL; AND

9 (2) THE PUBLISHING OF THE PERSONAL INFORMATION RESULTS IN:

10 (I) AN ASSAULT IN ANY DEGREE;

11 (II) HARASSMENT;

12 (III) TRESPASS; OR

13 (IV) MALICIOUS DESTRUCTION OF PROPERTY.

14 (B) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR
15 AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 18 MONTHS

20 **(b) "ACP number" means the unique identification number assigned to each**
21 **program participant by the Secretary OR BY THE OFFICE OF INFORMATION PRIVACY.**

22 **(c) "Actual address" means a residential street address, school address, or work**
23 **address of an individual, as specified on the individual's application to be a program**
24 **participant under Title 7, Subtitle 3 of the State Government Article.**

25 **(d) "Address Confidentiality Program" means the Address Confidentiality**
26 **Program for survivors of threatened, attempted, or actual domestic violence, sexual assault,**
27 **stalking, harassment, or human trafficking administered by the Secretary under Title 7,**
28 **Subtitle 3 of the State Government Article AND THE JUDICIAL ADDRESS**

8 (v) Driver’s license number.

9 (F) “OFFICE OF INFORMATION PRIVACY” MEANS THE OFFICE OF
10 INFORMATION PRIVACY IN THE ADMINISTRATIVE OFFICE OF THE COURTS.

11 [(f)] (G) “Program participant” means an individual designated by the Secretary
12 OR BY THE OFFICE OF INFORMATION PRIVACY as a participant in an address
13 confidentiality program.

14 [(g)] (H) “Real Property ACP Notice” means the notice required under this part
15 for a program participant to request the shielding of real property records.

16 [(h)] (I) “Real property record” means any record or data maintained by a clerk
17 of the circuit court or a State or local agency as part of the land or tax records.

18 [(i)] (J) “Secretary” means the Secretary of State.

19 [(j)] (K) “Shield” means to remove real property records from public inspection
20 in accordance with this part.

21 [(k)] (L) “Shielding” means, with respect to a real property record accepted for
22 recording by a clerk of the circuit court or a State or local agency, removing the record to a
23 separate secure area to which persons who do not have a legitimate reason for access are
24 denied access.

25 SECTION 2. AND BE IT FURTHER ENACTED, That:

26 (a) There is a Task Force to Ensure the Safety of Judicial Facilities.

27 (b) The Task Force consists of the following members:

28 (1) the Chief Justice of the Supreme Court of Maryland;

- 1 (2) the Chief Judge of the Appellate Court of Maryland;
- 2 (3) the Chair of the Conference of Circuit Judges, or the Chair's designee;
- 3 (4) two circuit court administrative judges from counties with varying
4 population densities, appointed by the Chief Justice of the Supreme Court of Maryland;
- 5 (5) the Chief Judge of the District Court of Maryland;
- 6 (6) two District Court administrative judges from counties with varying
7 population densities, appointed by the Chief Justice of the Supreme Court of Maryland;
- 8 (7) three members of county leadership or their designees, from counties
9 with varying population densities, appointed by the Governor;
- 10 (8) one member of the Senate of Maryland, appointed by the President of
11 the Senate;
- 12 (9) one member of the House of Delegates, appointed by the Speaker of the
13 House;
- 14 (10) three sheriffs or their designees, from counties with varying population
15 densities, appointed by the Governor;
- 16 (11) the Superintendent of the Maryland State Police, or the
17 Superintendent's designee;
- 18 (12) the Secretary of General Services, or the Secretary's designee;
- 19 (13) the Secretary of Budget and Management, or the Secretary's designee;
- 20 (14) the Secretary of Public Safety and Correctional Services, or the
21 Secretary's designee;
- 22 (15) three chiefs of police or their designees, from counties with varying
23 population densities, appointed by the Governor;
- 24 (16) a magistrate from a circuit court, appointed by the Chief Justice of the
25 Supreme Court of Maryland;
- 26 (17) one clerk of a circuit court, appointed by the Chief Justice of the
27 Supreme Court of Maryland;
- 28 (18) the Director of Commissioners for the District Court of Maryland;
- 29 (19) the Chief of Security Administration for the Administrative Office of
30 the Courts;

1 (20) one District Court bailiff, appointed by the Chief Justice of the Supreme
2 Court of Maryland; and

3 (21) one representative of the Maryland Association of Counties, appointed
4 by the Governor.

5 (c) The Chief Justice of the Supreme Court of Maryland shall chair the Task
6 Force.

7 (d) The Administrative Office of the Courts shall provide staff for the Task Force.

8 (e) A member of the Task Force:

9 (1) may not receive compensation as a member of the Task Force; but

10 (2) is entitled to reimbursement for expenses under the Standard State
11 Travel Regulations, as provided in the State budget.

12 (f) The Task Force shall:

13 (1) identify minimum requirements for courthouse safety, including:

14 (i) the minimum number of security officers that should be present
15 in each type of judicial proceeding in a circuit court or in the District Court;

16 (ii) the minimum qualifications for security officers;

17 (iii) minimum standards for secure entry and exit of judicial officers
18 from court facilities, including for secure parking and, if such parking is not connected to
19 the courthouse, secure transit between parking and the courthouse; and

20 (iv) minimum standards for safe public areas of courthouses,
21 including for the protection of judicial officers who are required to enter public areas of the
22 courthouse in the performance of their public duties;

23 (2) develop a legislative proposal to ensure that the requirements
24 identified under item (1) of this subsection can be met; and

25 (3) identify physical security deficiencies that currently exist in
26 courthouses and develop a plan to address these deficiencies.

27 (g) On or before January 1, 2025, the Task Force shall report its findings and
28 recommendations to the Chief Justice of the Supreme Court of Maryland and, in accordance
29 with § 2-1257 of the State Government Article, the General Assembly.

1 SECTION 3. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall take
2 effect October 1, 2024.

3 SECTION 4. AND BE IT FURTHER ENACTED, That, except as provided in Section
4 3 of this Act, this Act shall take effect June 1, 2024. Section 2 of this Act shall remain
5 effective for a period of 2 years and 1 month and, at the end of June 30, 2026, Section 2 of
6 this Act, with no further action required by the General Assembly, shall be abrogated and
7 of no further force and effect.
