# Article – Agriculture

18 2-504.1.

(a) In each county containing productive agricultural land, the county governingbody shall appoint an agricultural preservation advisory board.

(b) (1) Except as provided in paragraphs (2) and (3) of this subsection, the agricultural preservation advisory board shall consist of five members, at least three of whom shall be owner-operators of commercial farms who earn 50 percent or more of their income from farming.

1 (2)In Worcester County, the agricultural preservation advisory board shall  $\mathbf{2}$ consist of seven members, at least four of whom shall be owner-operators of commercial 3 farms who earn 50 percent or more of their income from farming. 4 In St. Mary's County, the agricultural preservation advisory board shall (3) $\mathbf{5}$ consist of five members, at least three of whom shall be actively pursuing the production of agricultural products for profit. 6 7 Except as provided in [paragraph (2)] PARAGRAPHS (2) AND (3) of (c)(1)this subsection, each member of an agricultural preservation advisory board shall be 8 appointed for a term of office of [five] 5 years. 9 10 (2)In Charles County and in Worcester County, a member shall serve a 11 term of office of 4 years. 12(3) IN HOWARD COUNTY, A MEMBER SHALL SERVE A TERM OF OFFICE 13OF 3 YEARS. 14**[**(3)**] (4)** No member shall serve for more than two consecutive full terms. 15**[**(4)**] (5)** Appointment to fill a vacancy shall be for the remainder of the 16unexpired term. 17(d) Duties of each agricultural preservation advisory board shall be: 18 To advise the county governing body with respect to the approval of (1)purchases of easements by the Foundation within the county; 19 20(2)To assist the county governing body in reviewing the status of land 21under easement; 22To advise the Foundation concerning county priorities for agricultural (3)23preservation; 24(4) To approve or disapprove an application by the county for certification 25or recertification under § 5–408 of the State Finance and Procurement Article; 26To promote preservation of agriculture within the county by offering (5)27information and assistance to farmers with respect to the purchase of easements; 28(6)To meet at least annually with forest conservation district boards in 29order to work cooperatively to encourage the promotion and retention of farmland and woodland in their respective jurisdictions; and 30 To perform any other duties as assigned by the county governing body. 31(7)

#### SENATE BILL 1128

#### 1 SECTION 2. AND BE IT FURTHER ENACTED, That:

2 (a) The members of the agricultural preservation advisory board in Howard 3 County currently serving on the effective date of this Act may serve for the remainder of 4 their 5-year terms.

5 (b) Each subsequent member appointed after the effective date of this Act shall 6 serve for a term of 3 years, as enacted by Section 1 of this Act.

7 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 October 1, 2024.
