7	to a certain concessionaire; authorizing beer, wine, and liquor purchased under the
8	license to be consumed in certain areas; providing for the hours and days of sale and
9	an annual license fee; and generally relating to alcoholic beverages licenses in Prince

21	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 2 (A) IN THIS SECTION, "CONCESSIONAIRE" MEANS A LESSEE, A SUBLESSEE,
- 3 OR ANY OTHER OPERATOR OF AN ESTABLISHMENT THAT IS CONTRACTED BY THE
- 4 HOLDER OF A CLASS B-ECF/DS BEER, WINE, AND LIQUOR LICENSE TO PROVIDE
- 5 FOOD AND BEVERAGES SERVICES IN DESIGNATED AREAS OF VENUES THAT ARE:
- 6 (1) LOCATED ON THE UNIVERSITY OF MARYLAND, COLLEGE PARK 7 CAMPUS; AND
- 8 (2) USED PRIMARILY TO HOST COLLEGE ATHLETIC EVENTS.
- 9 (B) THERE IS A CLASS B-CAEVC (COLLEGE ATHLETIC EVENT VENUE 10 CONCESSIONAIRE) BEER, WINE, AND LIQUOR LICENSE.
- 11 (C) THE BOARD MAY ISSUE THE LICENSE TO A CONCESSIONAIRE.
- 12 (D) (1) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER,
- 13 WINE, AND LIQUOR BY THE GLASS OR BY THE BOTTLE FOR ON-PREMISES
- 14 CONSUMPTION:
- 15 (I) IN THE AREA OF THE VENUE PRIMARILY USED TO HOST
- 16 COLLEGE ATHLETIC EVENTS, INCLUDING COURTSIDE SEATING AND SUITES AT THE
- 17 VENUE; AND
- 18 (II) IN ANY OTHER AREA OF THE VENUE CONTROLLED BY THE
- 19 HOLDER OF A CLASS B-ECF/DS BEER, WINE, AND LIQUOR LICENSE.
- 20 (2) THE LICENSE HOLDER MAY RESTRICT ACCESS TO THE LICENSED
- 21 PREMISES.
- 22 (E) NOTWITHSTANDING § 26–1009(D)(2) OF THIS SUBTITLE, BEER, WINE,
- 23 AND LIQUOR PURCHASED FROM AN OUTLET CONTROLLED BY THE HOLDER OF A
- 24 CLASS B-ECF/DS LICENSE MAY BE CONSUMED AT THE PREMISES CONTROLLED BY
- 25 THE HOLDER OF A CLASS B-CAEVC LICENSE.
- 26 (F) A SEPARATE CLASS B-CAEVC BEER, WINE, AND LIQUOR LICENSE IS
- 27 REQUIRED FOR EACH VENUE IN WHICH THE CONCESSIONAIRE OPERATES.
- 28 (G) THE LICENSE MAY NOT BE COUNTED AS A CLASS B LICENSE FOR
- 29 PURPOSES OF § 26–1601 OF THIS TITLE.

- 1 (H) THE LICENSE HOLDER MAY SELL BEER, WINE, AND LIQUOR DURING THE 2 HOURS AND DAYS AS SET OUT FOR A CLASS B BEER, WINE, AND LIQUOR LICENSE 3 UNDER § 26–2004 OF THIS TITLE.
- 4 (I) (1) THE ANNUAL FEE FOR THE LICENSE IS \$3,500.
- 5 (2) THE FEE SHALL BE PAID TO THE BOARD ON OR BEFORE MAY 1.
- $\,\,$ SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July $\,7\,$ $\,$ 1, 2024.
