Montgomery County through immersive programs rooted in our restorative rural setting, which is unique among art centers in the D.C. region.

Riverworks Arts Center will renovate and rehabilitate the Old Methodist Church historic property at 17605 West Willard Rd. in Poolesville, turning this historic structure into a state-of-the-art performing arts center. Complementing its custom-designed sound system and an interior beautified by locally milled wood, the site will feature a unique, interchangeable stage allowing performers to face both indoor and outdoor audiences and offer gathering space for exhibits, lectures, performances, roundtables, and other events. We plan a beautiful setting surrounded by gardens and conservation landscaping demonstrating effective yet attractive stormwater management. The performing arts center will be a launching pad for expansive arts engagement, arts education, and cultural activities in town.

## 28. Comments

Established as a nonprofit in 2022, Riverworks Art Center has offered over 100 art classes, performances, public events, exhibitions, receptions, concerts, childrens activities and cultural programs at three locations in and around Poolesville in just its first 18 months. In partnership with the Poolesville Commissioners, local non-profit organizations, businesses, schools and civic organizations (e.g., Locals Farm Market, Hope Garden Children's Ballet Theater, Essence Dance Studio, Heritage Montgomery, Blackrock Center for the Arts, Montgomery County Lynching Memorial Project, the Butz Family Foundation, Poolesville Seniors, WUMCO, Historic Medley District, Upcounty Prevention Network, Poolesville Pride, Poolesville Area Chamber of Commerce, the Barnesville School), the arts center will continue to offer cultural events, and inspiration, and avenues to well-being to a diverse group of local and county residents and visitors, furthering Poolesville's renowned community connection.

The Riverworks Performing Arts Center, located in the Poolesville Heritage District and Montgomery County's Agricultural Reserve, will help to elevate Poolesville and the Agricultural Reserve, attracting visitors for increased visibility and economic activity for businesses and other cultural endeavors throughout the community, thus contributing to employment creation and increased income for local business.

We have deep community support for Riverworks Art Center and the project, as evidenced by popular and sold out fundraising events. For the capital campaign, we are working with a highly experienced fundraiser that specializes in major gifts and have already received commitments of over \$400,000. In addition, we are working with the Montgomery County government, Heritage Montgomery/Maryland Heritage Areas Authority, and the Town of Poolesville for additional funding. We have completed engineering and design plans for this project. This LBI funding will move us an important step closer to finalizing our project financing. We are confident that this project will be ready to proceed with construction within the preferred 18-month period from the effective date of the capital budget bill in which we would be honored to receive funding.
