House Bill 337

(Delegate Love, *et al.*)

Vehicle Laws - Bike Lanes and Shoulders - Yielding Right-of-Way (Sarah
 Debbink Langenkamp Memorial Act)

This bill establishes increased penalties for a driver of a vehicle who fails to yield the right-of-way in a designated bike lane or shoulder to a person lawfully riding a bicycle, an electric personal assistive mobility device (EPAMD), or a motor scooter if the driver contributes to the serious physical injury or death of a person riding a bicycle, EPAMD, or motor scooter. A violator is subject to imprisonment for up to two months and/or a maximum fine of \$2,000.

Fiscal Summary

State Effect: General fund expenditures for the Judiciary increase by \$56,900 in FY 2025 only for programming changes. Otherwise, the bill is not expected to materially affect State finances or operations.

Local Effect: The bill is not expected to materially affect local finances or operations.

Small Business Effect: None.

Analysis

Current Law: Pursuant to § 21-1209(d) of the Transportation Article, the driver of a vehicle must yield the right-of-way to a person who is lawfully riding a bicycle, an EPAMD, or a motor scooter in a designated bike lane or shoulder if the driver of the vehicle is about to enter or cross the designated bike lane or shoulder. A violation is a misdemeanor that carries a fine of up to \$500. The prepayment penalty is \$80 for a standard violation and \$120 for a violation that contributes to an accident. The Motor Vehicle Administration must assess one point for a standard violation and three points for a violation that contributes to an accident.

Additional Comments: The Judiciary advises that, in fiscal 2023, there were six violations (charges) and two guilty dispositions (convictions) under § 21-1209(d) of the Transportation Article in the District Court and one citation and zero guilty dispositions in the State's circuit courts. In fiscal 2022, there were five violations and four guilty dispositions in the District Court under § 21-1209(d); no charges were filed in the circuit courts. The Judiciary advises that its data does not indicate which, if any, of the violations charged in fiscal 2022 and 2023 involved the serious physical injury or death of a person riding a bicycle, an EPAMD, or a motor scooter.

Additional Information

Recent Prior Introductions: Similar legislation has not been introduced within the last three years.
