### 1 AN ACT concerning

### 2 State Buildings and State Highways – Collection and Disposal of Yard Waste

FOR the purpose of prohibiting a person from disposing of yard waste collected on the grounds of a State building or State highway in a certain container; requiring a person to collect yard waste on the grounds of a State building or State highway in a certain container; requiring all yard waste collected on the grounds of a State building or State highway to be disposed of in a certain manner <u>under certain</u> <u>circumstances</u>; and generally relating to the collection and disposal of yard waste from the grounds of State buildings and State highways.

# SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

### 19 SUBTITLE 10. COLLECTION AND DISPOSAL OF YARD WASTE.

17 (III) AN IMPROVEMENT OF A PUBLIC AREA USED FOR 18 GATHERING OR AMUSEMENT, INCLUDING A STATE PARK, RECREATION CENTER, OR 19 SIMILAR AREA.

20 (E) (1) "STATE HIGHWAY" HAS THE MEANING STATED IN § 8–101 OF THE 21 TRANSPORTATION ARTICLE.

22 (2) "STATE HIGHWAY" INCLUDES ANY LAND OWNED BY THE STATE 23 THAT IS ADJACENT TO A STATE HIGHWAY.

24(F)(1)"YARD WASTE" MEANS ORGANIC PLANT WASTE DERIVED FROM25GARDENING, LANDSCAPING, AND TREE TRIMMING ACTIVITIES.

26 (2) "YARD WASTE" INCLUDES LEAVES, GARDEN WASTE, LAWN 27 CUTTINGS, WEEDS, AND PRUNINGS.

#### HOUSE BILL 338

1 (A) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, 2 THIS SECTION APPLIES TO A PERSON WHO:

3 (I) IS AN EMPLOYEE OF THE STATE WHO COLLECTS YARD
 4 WASTE ON THE GROUNDS OF A STATE BUILDING OR STATE HIGHWAY AS PART OF
 5 THAT PERSON'S EMPLOYMENT; OR

6 (II) CONTRACTS WITH THE STATE TO PROVIDE SERVICES ON 7 THE GROUNDS OF A STATE BUILDING OR STATE HIGHWAY, INCLUDING THE 8 COLLECTION OF YARD WASTE.

9 (2) THIS SECTION DOES NOT APPLY TO A PERSON WHO IS DISPOSING 10 OF:

11(I)NOXIOUS WEEDS, AS DESIGNATED BY THE DEPARTMENT OF12AGRICULTURE; OR

13 (II) INVASIVE SPECIES.

14 (B) A PERSON MAY NOT DISPOSE OF YARD WASTE COLLECTED ON THE 15 GROUNDS OF A STATE BUILDING OR STATE HIGHWAY IN A SINGLE-USE PLASTIC 16 CONTAINER.

17 (C) A PERSON SHALL COLLECT YARD WASTE ON THE GROUNDS OF A STATE 18 BUILDING OR STATE HIGHWAY IN A CONTAINER THAT:

- 19 (1) WILL NOT BE DISCARDED WITH THE YARD WASTE; OR
- 20 (2) IS A COMPOSTABLE PAPER BAG.
