3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

4 That:

5 (a) The Maryland Department of Health shall review the cost reports and other
6 data submitted by each nursing home that participates in the Maryland Medical Assistance
7 Program, including data related to revenues allocated to:

8 (1) contracted nursing care services; and

9 (2) salaries and wages of all direct care nonadministrative staff, including:

10 (i) certified nurse aides;

11 (ii) directors of nurses;

12 (iii) licensed practical nurses;

13 (iv) noncertified or resident care aides;

14 (v) registered nurses;

15 (vi) housekeepers;

16 (vii) dietary workers; and

17 (viii) in-house clerical staff who regularly interact with residents,
18 Maryland Medical Assistance Program recipients, and caregivers.

19 (b) On or before October 1, 2025, and on or before October 1 each year thereafter
20 through 2029, the Maryland Department of Health shall report the findings resulting from
21 the review conducted under subsection (a) of this section to the Governor and, in accordance
22 with § 2-1257 of the State Government Article, the Senate Finance Committee and the
23 House Health and Government Operations Committee.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
25 1, 2025.
