# Department of Aging - Social Connections Program - Establishment Senior Call-Check and Social Connections Program

- 4 FOR the purpose of renaming the Senior Call-Check Service and Notification Program to 5 be the Senior Call-Check and Social Connections Program; repealing altering 6 certain provisions of law related to the Senior Call-Check Service and Notification 7 Program; establishing the Social Connections Program to provide certain 8 communication to eligible older adults to promote wellness and purposeful social 9 engagement: authorizing the integration of services between the Program and 10 Telecommunications Access of Maryland; authorizing the Department of Aging and the Department of Disabilities to collaborate on developing the Program budget; and 11 generally relating to the Department of Aging and the Senior Call-Check and Social 12 Connections Program. 13
