A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Social Work Examiners – Conditional License to Practice Social
3 Work – Revisions**

4 FOR the purpose of altering the circumstances under which the Board of Social Work
5 Examiners may issue a conditional license to practice social work; establishing
6 alternate pathways through which an individual issued a conditional license may
7 receive a full license; and generally relating to licenses to practice social work.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Health Occupations**

21 19–101.

22 (a) In this title the following words have the meanings indicated.

(c-1) "Conditional license" means a license issued by the Board under, and as limited by, § 19-309.1 of this title to practice:

3 (1) Bachelor social work; or

4 (2) Master social work.

5 (e) "License" means, unless the context requires otherwise:

6 (1) One of four categories of licenses issued by the Board authorizing an
7 individual to practice:

8 (i) Bachelor social work;

9 (ii) Master social work;

10 (iii) Certified social work; or

11 (iv) Certified social work-clinical; or

12 (2) A conditional license issued by the Board.

13 or occurrence prevents an examination required under this subtitle from being available to
14 an applicant for a period of at least 15 business days, the] **THE** Board [may] **SHALL** issue
15 a conditional license to an applicant who, except for passing the examination **OTHERWISE**
16 **REQUIRED UNDER THIS SUBTITLE**, has met the appropriate education and experience
17 requirements of this subtitle for a license issued under § 19–302 of this subtitle to practice:

20 (1) Bachelor social work; or

21 (2) Master social work.

22 (b) A conditional license issued under this section [authorizes]:

(1) EXPIRES ON A DATE SET BY THE BOARD THAT IS AT LEAST 12 MONTHS, BUT NOT MORE THAN 24 MONTHS, AFTER THE DATE OF ISSUANCE;

5 (2) MAY NOT BE RENEWED; AND

6 (3) SHALL TERMINATE AUTOMATICALLY ON:

7 (I) THE EXPIRATION DATE; OR

11 (D) A HOLDER OF A CONDITIONAL LICENSE UNDER THIS SECTION AND THE
12 SUPERVISING SOCIAL WORKER ARE JOINTLY RESPONSIBLE FOR ENSURING
13 COMPLIANCE WITH THE SUPERVISION AND EXPIRATION REQUIREMENTS OF
14 SUBSECTIONS (B)(2) AND (C) OF THIS SECTION.

15 (E) THE BOARD SHALL ISSUE A FULL LICENSE UNDER § 19-302 OF THIS
16 SUBTITLE TO A HOLDER OF A CONDITIONAL LICENSE UNDER THIS SECTION WHO
17 DEMONSTRATES TO THE SATISFACTION OF THE BOARD THAT THE HOLDER HAS:

(1) ACHIEVED A SATISFACTORY SCORE ON AN EXAMINATION, AS
REQUIRED UNDER § 19-302 OF THIS SUBTITLE; OR

25 (I) IS ACCREDITED BY THE COUNCIL ON SOCIAL WORK
26 EDUCATION OR AN EQUIVALENT ORGANIZATION APPROVED BY THE COUNCIL ON
27 SOCIAL WORK EDUCATION; AND

30 **(F) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SECTION,**
31 **INCLUDING REGULATIONS THAT ESTABLISH:**

1 (1) MINIMUM SUPERVISION REQUIREMENTS AND REPORTING 2 PROCEDURES;

5 (3) REQUIREMENTS TO ENSURE THAT THE TRACKING OF
6 CONDITIONAL LICENSES ISSUED UNDER THIS SECTION ALIGNS WITH EXISTING
7 LICENSURE CYCLES; AND

11 **(d) (G)** On or before December 31 each year, beginning in **[2024,] 2026**, the
12 Board shall report to the Senate Finance Committee and the House Health and
13 Government Operations Committee, in accordance with § 2-1257 of the State Government
14 Article, the following information for the immediately preceding 12-month period:

15 [(1) Whether the examination was unavailable at any time during the
16 reporting period; and

17 (2) If the examination was unavailable:

18 (i) The number of applicants who were eligible for a conditional
19 license due to the unavailability of the examination;

20 (ii) The number of applicants who applied to take the examination;

21 (iii) The number of applications that were delayed in processing; and

(iv) The number of conditional licenses issued under this section.]

27 (3) ANY RECOMMENDATIONS FOR IMPROVING:

28 (I) THE IMPLEMENTATION OF THIS SECTION: AND

1 (II) THE IMPACT OF THIS SECTION ON THE HEALTH CARE
2 WORKFORCE.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency
4 measure, is necessary for the immediate preservation of the public health or safety, has
5 been passed by a yea and nay vote supported by three-fifths of all the members elected to
6 each of the two Houses of the General Assembly, and shall take effect from the date it is
7 enacted.
