## A BILL ENTITLED

1 AN ACT concerning

2 **Charles County – Summer Academy for Mathematics and Service Pilot Program**  
3 **– Establishment**

4 FOR the purpose of establishing the Summer Academy for Mathematics and Service Pilot  
5 Program within the Maryland Department of Labor to provide mathematics  
6 instruction to certain students in Charles County; requiring the Charles County  
7 public school system to implement the Program; requiring the Department to provide  
8 grants to the Charles County public school system for the Program; and generally  
9 relating to the establishment of the Summer Academy for Mathematics and Service  
10 Pilot Program.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
22 That the Laws of Maryland read as follows:

### Article – Education

1                   (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS  
2 INDICATED.

3                   (2) "ELIGIBLE STUDENT" HAS THE MEANING STATED IN § 11-608 OF  
4 THE LABOR AND EMPLOYMENT ARTICLE.

5                   (3) "PROGRAM" MEANS THE SUMMER ACADEMY FOR MATHEMATICS  
6 AND SERVICE PILOT PROGRAM ESTABLISHED UNDER § 11-608 OF THE LABOR AND  
7 EMPLOYMENT ARTICLE.

8                   (B) THIS SECTION APPLIES ONLY IN CHARLES COUNTY.

9                   (C) (1) IN PARTNERSHIP WITH THE MARYLAND DEPARTMENT OF LABOR,  
10 THE CHARLES COUNTY PUBLIC SCHOOL SYSTEM SHALL IMPLEMENT THE PROGRAM  
11 TO PROVIDE TARGETED INSTRUCTION IN A 6-WEEK COURSE OFFERED DURING  
12 SUMMER BREAK TO ELIGIBLE STUDENTS WHO ARE NOT PROFICIENT IN ALGEBRA OR  
13 GEOMETRY.

14                   (2) IN IMPLEMENTING THE PROGRAM UNDER PARAGRAPH (1) OF  
15 THIS SUBSECTION, THE CHARLES COUNTY PUBLIC SCHOOL SYSTEM SHALL:

16                   (I) USE EVIDENCE-BASED MATHEMATICS INTERVENTIONS  
17 AND ADAPTIVE LEARNING TECHNOLOGY;

18                   (II) OFFER TRANSPORTATION CONSISTENT WITH  
19 TRANSPORTATION AID GUIDELINES; AND

20                   (III) OFFER MEAL ACCESS CONSISTENT WITH THE MARYLAND  
21 MEALS FOR ACHIEVEMENT PROGRAM.

22                   (D) THE CHARLES COUNTY PUBLIC SCHOOL SYSTEM MAY PARTNER WITH:

23                   (1) COMMUNITY COLLEGES OR UNIVERSITIES WITH TEACHER  
24 PREPARATION PROGRAMS;

25                   (2) PUBLIC LIBRARIES;

26                   (3) STEM LEARNING CENTERS; OR

27                   (4) NONPROFIT OR COMMUNITY-BASED ORGANIZATIONS WITH  
28 DEMONSTRATED SUCCESS IN ACADEMIC TUTORING OR MATHEMATICS  
29 ENRICHMENT.

## Article – Labor and Employment

12 11-608.

13 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS  
14 INDICATED.

17 (I) SCORED BELOW A PROFICIENT LEVEL ON THE MOST  
18 RECENT STATE ASSESSMENT IN MATHEMATICS; OR

24 (B) THERE IS A SUMMER ACADEMY FOR MATHEMATICS AND SERVICE  
25 PILOT PROGRAM WITHIN THE DEPARTMENT.

26 (C) THE PURPOSE OF THE PROGRAM IS TO PROVIDE MATHEMATICS  
27 INSTRUCTION TO ELIGIBLE STUDENTS IN THE CHARLES COUNTY PUBLIC SCHOOL  
28 SYSTEM TO MITIGATE THE EFFECTS OF LEARNING LOSS AND PROMOTE STUDENT  
29 ACCELERATION.

1                   **(D) THE DEPARTMENT SHALL:**

2                   **(1) DEVELOP AND ISSUE STANDARDS FOR THE PROGRAM,**  
3    INCLUDING:

4                   **(I) MINIMUM INSTRUCTIONAL HOURS;**

5                   **(II) CURRICULUM ALIGNMENT WITH STATE STANDARDS; AND**

6                   **(III) TEACHER QUALIFICATIONS;**

7                   **(2) ESTABLISH PERFORMANCE INDICATORS TO EVALUATE PROGRAM**  
8    EFFECTIVENESS;

9                   **(3) PROVIDE TECHNICAL ASSISTANCE TO THE CHARLES COUNTY**  
10   PUBLIC SCHOOL SYSTEM; AND

11                  **(4) AWARD GRANTS TO THE CHARLES COUNTY PUBLIC SCHOOL**  
12   SYSTEM FOR PROGRAM OPERATION.

13                  **(E) (1) THE DEPARTMENT SHALL PRIORITIZE THE USE OF AVAILABLE**  
14   FUNDING FOR THE PROGRAM.

15                  **(2) FUNDS SHALL BE DISTRIBUTED TO THE CHARLES COUNTY**  
16   PUBLIC SCHOOL SYSTEM BASED ON THE NUMBER OF ELIGIBLE STUDENTS.

17                  **(3) FUNDS MAY BE USED FOR:**

18                  **(I) TEACHER STIPENDS;**

19                  **(II) INSTRUCTIONAL MATERIALS AND TECHNOLOGY; AND**

20                  **(III) PROGRAM EVALUATION AND DATA COLLECTION.**

21                  **(F) THE DEPARTMENT SHALL COMPILE AND PUBLISH A SUMMARY OF THE**  
22   INFORMATION REPORTED IN ACCORDANCE WITH § 7-137 OF THE EDUCATION  
23   ARTICLE, INCLUDING:

24                  **(1) AGGREGATED AND DISAGGREGATED DATA BY GRADE LEVEL,**  
25   SCHOOL, AND DEMOGRAPHIC SUBGROUP;

26                  **(2) TRENDS IN MATHEMATICS PROFICIENCY; AND**

### 1 (3) RECOMMENDATIONS FOR PROGRAM PARTICIPATION AND 2 RESOURCE ALLOCATION.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
4 October 1, 2026. It shall remain effective for a period of 14 years and, at the end of  
5 September 30, 2040, this Act, with no further action required by the General Assembly,  
6 shall be abrogated and of no further force and effect.
