Summary of Recommended Bond Actions

1. Accessibility Modifications

Approve funding for the Accessibilities Modifications program.

Program Analysis and Performance Measures

The Accessibilities Modifications program, also known as Access Maryland, provides funds to eliminate architectural barriers in State-owned facilities and allows the State to move toward compliance with the federally mandated Americans with Disabilities Act (ADA) of 1990. The program helps reduce the liability of the State for noncompliance with the ADA. It also helps to increase access to State programs, services, and employment opportunities. Each year, the Maryland Department of Disabilities (MDOD) requests projects for funding from State agencies and the public higher education institutions. The projects funded within this program are part of a long-term effort, and the program will require funding beyond the current *Capital Improvement Program (CIP)*.

Starting with fiscal 2013, agencies must have a transition plan on file with MDOD to receive funding in the allowance. The deadline for fiscal 2014 was January 1, 2012. At that time, 12 State agencies had transition plans on file with MDOD, up from 6 a year ago. It is unknown when MDOD will have a transition plan on file for all State agencies with accessibility needs. The agencies with plans currently on file are as follows:

- Bowie State University;
- Coppin State University (CSU);
- Department of General Services;
- Department of Natural Resources;

- Department of Public Safety and Correctional Services;
- Historic St. Mary's City;
- Morgan State University;
- Towson University;
- University of Maryland, Baltimore (UMB);
- University of Maryland Baltimore County (UMBC);
- University of Maryland, College Park (UMCP); and
- University of Maryland Eastern Shore.

Transition plans are revised and resubmitted to MDOD on a three-year cycle and the next round of updates is due in January 2014 to be eligible for Access Maryland in fiscal 2016 to 2018. Agencies that are currently eligible but do not submit updates will no longer have access to Access Maryland until they do so.

The projects under this program must complete design within two years of receiving approval from the General Assembly to remain eligible for funding. In addition, starting in fiscal 2010, agencies were required to initiate construction within six months of approval of design. These policies are intended to ensure that projects are completed in a timely manner. Although three projects have received extensions due to external approval delays, no projects have lost funding due to these progression policies since fiscal 2006.

It should be noted that in the event a project is declared ineligible, the agency is not relieved of the obligation to make the modification, just that the project will not be funded using Access Maryland funds. MDOD has no way to ensure the project is actually completed. However, for most State agencies, Access Maryland is the only source of funds for small scale facility improvements.

The Accessibilities Modifications program is administered on a cash flow basis, and projects are funded on a first-come, first-served basis until funds are exhausted. In prior years, the allowance would fund projects previously approved by the General Assembly but not yet initiated. MDOD worked to eliminate this use of carryover projects to allow for more projects to be funded in a given year, and fiscal 2013 was the first year with no carryover projects. Fiscal 2014 continues this practice, as there are no previously authorized projects receiving funding.

Budget Overview

The proposed fiscal 2014 general obligation (GO) bond authorization totals \$1.6 million, equal to that authorized in fiscal 2013. However, due to a program balance from lower than expected project costs in prior years, total spending in fiscal 2014 is estimated to be \$1.7 million. The CIP programs \$1.6 million annually for fiscal 2015 to 2018.

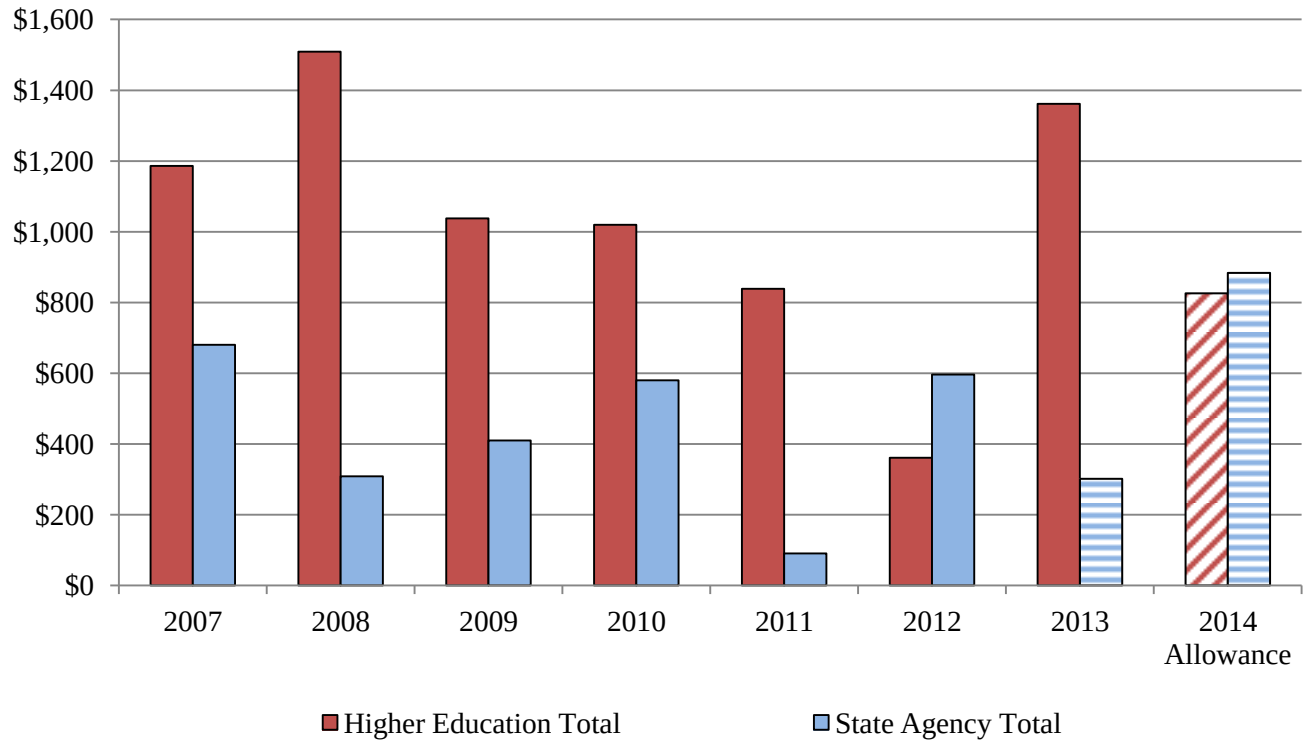
The nine projects included for funding in fiscal 2014 are comprised of five at higher education institutions (CSU, UMB, UMBC, and UMCP), two at correctional facilities (the Central Maryland Correctional Facility and the Eastern Pre-release Unit), one at a State park (Rocky Gap State Park), and one at a district court (Borgerding District Court).

The UMCP project modifies the entrance and elevators of the Potomac Building, a project that received \$79,760 in fiscal 2013 for design. The allowance includes \$623,000 for construction, the largest project in fiscal 2014. The Borgerding District Court project totals \$45,000 for planning of courtroom modifications, and \$293,000 is expected in fiscal 2015 for construction.

Higher Education Funding in Access Maryland

Higher education institutions have traditionally received the majority of funding under Access Maryland. MDOD puts a priority on these projects because higher education leads to greater employment opportunities and less reliance on State services. **Exhibit 1** shows that higher education received more funding than all other State agencies in each year since fiscal 2007 except fiscal 2012, as well as in the 2014 allowance.

Those two years notwithstanding, higher education institutions represent the greatest share of State-owned facilities and the majority of them were built before the accessibility requirements of the ADA. Higher education institutions also represent 8 of the 12 transition plans that MDOD has on file, so their needs are more documented than other State agencies.

However, the University System of Maryland (USM) receives \$17 million in GO bonds annually for facility renewal projects in the capital budget, and all higher education institutions have plant funds, an internal fund source that is used for facility improvements. State agencies do not have these alternative fund sources available and instead must rely on programs like Access Maryland. A year ago, MDOD reported that it was going to work with USM to try to develop a matching fund or other mechanism to address accessibility modifications at USM institutions. **MDOD should comment on the result of those discussions and if additional funding from higher education institutions themselves can be used to help address their accessibility needs.**

GO Bond Recommended Actions

1. Approve funding for the Accessibilities Modifications program.
