<p>From 2010, Meade High School and their athletic boosters began raising and applying for funds to build outdoor bathrooms and concession stand in our stadium. In 2012 we were hopeful to use this grant to reach our goal but came up short of the bids that were being placed. In 2014 Meade had a change in both the athletic director and booster board positions, which significantly set this project back. When this board caught up to the facts, they raised enough money in 2015 to complete this project. New plans are needed to complete this project and are currently being worked on.</p>
