## (10) In your own words, please describe in detail the project's background and your need for a prior authorization.

The Interfaith Watershed Restoration and Outreach Project is located on Beth Sholom Congregation and Talmud Torah property and at the crossroads with St. James Episcopal Church. Our overall vision is that this project will be complementary to current and future projects along Seven Locks to create a Watershed and Conservation green belt that is inter-faith and inter-community.

The main objectives of the Interfaith Watershed Restoration and Outreach Project are to (1) promote understanding of the green belt projects through the Early Childhood Center at Beth Sholom and the St. James Episcopal Children's School, the broader faith-based communities at both institutions, and provide a community workshop through Friends of Cabin John Creek, and (2) promote local usage of the walkway, including a small garden and educational opportunities.

(11) If you are requesting an extension of the date upon which evidence of a matching fund must be presented to the Board of Public Works, please explain the need for the extension. When do you expect to raise the requisite amount of matching funds, if at all?

The matching funds from the Chesapeake Watershed Restoration and Rainscapes community project are already committed and will be funded by the end of 2017. This project is shovel ready with all plans completed.

The matching funds for to complete this project are already committed and will be funded by year end 2017

The committed matching funds will be funded by year-end 2017.

The Interfaith Watershed Restoration and Outreach Project advances the broader goals of Montgomery County. First, this project advances the promotion of healthy and sustainable communities and a strong and vibrant economy. It does so because all of the design, implementation, procurement of goods and services, maintenance, workshops, and outreach materials are Montgomery County-based resulting in the creation of local jobs in the community and support for local economies. The project promotes community understanding of local environmental and educational project goals and outcomes. Our project will support the overarching vision of the Watershed Implementation Plan by generating environmental restoration projects, improving neighborhood streams, protecting our drinking water sources, promoting an understanding of environmental issues and ensuring a legacy for the future of children and families in our communities.

As a result of the joint planning for this project, both congregations have agreed that the space will serve as a community space for learning about watershed restoration efforts. Through the project, there will be experiential and sensory based learning opportunities through the colors, fragrances, sounds, visuals of the new park space, with interpretive signage subject to approval by Montgomery County. We are also developing new relationships with organizations like Friends of Cabin John Creek who have more extensive experience in developing workshops on education for the community. We hope these new relationships will also become of our on-going support and understanding of our environmental impact in our community. All of these activities complement on-going programming at our congregation that emphasizes community engagement and social action.

(15) If you are requesting to modify the name of the grantee organization, add another grantee organization, or remove a grantee organization, please explain the reason and need for the change. If applicable, do those organizations being added or removed as grantee consent to the change?

The request to change the name of the grantee organization to Beth Sholom is to reflect the correct institutional oversight entity that will manage the project from start to finish. The Beth Sholom staff will maintain the proposed improvements on an ongoing basis.
